### Amendment No. 1

This Amendment is entered into in the State of California by and between San Bernardino County, hereinafter called the County, and View Behavioral Health-Colton II, LLC dba View Behavioral Health Colton Children's referenced above, hereinafter called Contractor.

#### IT IS HEREBY AGREED AS FOLLOWS:

IN THAT CERTAIN **Contract No. 25-858** ("Contract") by and between San Bernardino County, a political subdivision of the State of California, and Contractor, which Contract first became effective November 4, 2025, the following changes are hereby made and agreed to in the Contract, effective upon execution of this Amendment:

- I. All references to "View Behavioral Health, LLC" in Contract No. 25-858 are hereby amended to read as "View Behavioral Health-Colton II, LLC dba View Behavioral Health Colton Children's".
