This License Agreement ("Agreement") is entered into by and between the SMG ONTARIO, LLC, a California limited liability company with corporate offices located at 2000 E. Convention Center Way, Ontario, California, ("SMG ONTARIO") and Elections Office of the Registrar of Voters with primary offices located at 777 East Rialto Avenue, San Bernardino, California 92415 ("LICENSEE").

#### SECTION 1 GRANT OF LICENSE; LICENSE PERIODS; EVENT REQUIREMENTS

Ontario Convention Center and/or any other facility ("Facilities") as set forth in the Summary of Basic Terms (the "Licensed Areas"). LICENSEE, its guests, exhibitors, patrons or invitees, shall have the exclusive right to use the Licensed Areas during the dates and times set forth in the Summary of Basic Terms (the "License Periods") in connection with the Event set forth in the Summary of Basic Terms. LICENSEE, its guests, exhibitors, patrons or invitees also shall have the non-exclusive right to use the restrooms and other areas in and adjacent to the Facilities (including but not limited to the Lobby area of the Facilities, and the outside areas adjacent to and surrounding the Facilities) that are available for public or common use ("Common Areas") for ingress and egress to the Licensed Areas. LICENSEE acknowledges that neither it, nor its attendees, exhibitors, contractors, patrons or invitees of any kind may use the Common Areas for marketing, promotion, exhibition or any other use, unless expressly permitted, and under such terms and conditions as set forth, by SMG ONTARIO. Notwithstanding the foregoing, LICENSEE may use Common Areas for registration, coat check, baggage storage and other similar administrative or convenience services, subject to reasonable conditions and restrictions placed on such use by SMG ONTARIO.

LICENSEE understands and agrees that this Agreement is a license for use of the specified Licensed Areas and Common Areas, and an agreement for services, and that it is not and does not constitute a lease or other rental agreement that would confer on LICENSEE any rights as a tenant under California landlord-tenant laws, including any rights to prior notice or cure under such laws, and

LICENSEE's right to occupy and use the Licensed Areas, Common Areas and services may be terminated in accordance with the terms set forth in this Agreement.

In the event LICENSEE's use of the Licensed Areas commences prior to or extends beyond the time periods set forth in the Summary of Basic Terms, the License Periods shall be deemed to include such time periods and all terms and conditions of this Agreement shall apply to the extended periods. SMG Ontario may charge an additional license fee for such extended use.

1.2 Event Requirements No later than 60 days before the first day of the event, LICENSEE shall provide SMG ONTARIO, for SMG ONTARIO's approval, six (6) copies of a full and complete floor plan (no less than 1/16 scale) for the event, and, if requested, furnish a description of all electrical, communications systems, and plumbing work. Such floor plans shall indicate all spaces to be used for exhibits, registration, demonstration areas and stages and include certified approval from the Ontario Fire Marshal. SMG ONTARIO hereby reserves the right, by written notice to the LICENSEE within ten (10) days of receipt of the floor plan, to require LICENSEE to make such changes, deletions and additions in the floor plan and the operation policies described therein as SMG ONTARIO and Fire Marshal may deem reasonable, necessary or desirable to the safe and efficient operation of the CENTER. Failure to comply with this provision may be cause for cancellation of your event and loss of fees.

LICENSEE shall provide SMG ONTARIO with all other information required by SMG ONTARIO concerning the event such as room or hall set-ups, staging, and food and beverage requirements no later than 60 days before the first contracted move-in day. In no event will SMG ONTARIO be responsible for any injury, harm, or damage arising from the late delivery of any such information. If LICENSEE fails to provide this information as required, it shall pay to SMG ONTARIO the cost of SMG ONTARIO's additional labor and any other fees arising from such delay. SMG ONTARIO shall be the sole judge of what additional labor or fees are required as a result of the delay. Any changes concerning the event requested by the SMG ONTARIO within ten (10) days of the first day of the event may be subject to a premium charge.

LICENSEE acknowledges that it bears the sole risk of loss if it sells exhibit space within the CENTER before performing all of its obligations under this Agreement, including but not limited to payment of all fees due under this Agreement, obtaining SMG ONTARIO's approval of floor plans, supplying certificates or policies of insurance pursuant to Section 5. In the event the submitted floor plan by the LICENSEE for Exhibit Hall blocks, any portion of the concession areas within the CENTER, thereby preventing the ability for the CENTER's concession sales, a food buyout of \$2.00 per person from the estimated attendance will be assessed. Pricing per person is subject to change without prior notice.

#### SECTION 2 LICENSE FEE; CHARGES FOR SERVICES; PAYMENT

- 2.1 <u>License Fee</u>. LICENSEE shall pay SMG ONTARIO the License Fee set forth in the Summary of Basic Terms.
- **2.2** Ancillary Services Fee. In addition to the License Fee, LICENSEE shall pay for services, to the extent used by LICENSEE, at the rates in effect on the first day of the Event. SMG ONTARIO may in its discretion require payment of deposits on the Ancillary Services Fee prior to LICENSEE's Event.
- 2.3 Payment. The License Fee is due and payable upon execution of this Agreement. Alternatively, incremental deposits shall be made on the dates and in the amounts set forth in the Summary of Basic Terms. All deposits are non-refundable, unless this Agreement is canceled pursuant to the Force Majeure provision in Section 7.2. Any unpaid License Fee, Ancillary Services Fee, or other amounts owed to SMG ONTARIO are due and payable upon demand or presentation of an invoice to LICENSEE. Invoices that remain unpaid after thirty (30) days shall accrue interest on the unpaid balance at the rate of one and one-half percent (1.5%) per month. All accounts turned over for collections or legal pursuits are charged reasonable collection costs/attorney fees.

#### SECTION 3 SERVICES

- 3.1 Services Provided by SMG ONTARIO. SMG ONTARIO shall furnish, without cost to LICENSEE on days of the Event (Event Day(s)) (fees may apply for heat, air conditioning or overhead lighting during move-in/out), normal heat or air conditioning, overhead lighting, restroom facilities, janitorial services consisting of cleaning of common public areas, and one set-up per contracted Event Day(s) for meeting, general session, or banquet areas, provided that LICENSEE complies with the requirements of this paragraph. Inventory is based upon availability. The LICENSEE or its exhibitors, or performers shall pay the cost of audio, video, telecommunications, data, fiber, Internet, special lighting, electricity, gas, water or other utilities required for exhibits or performances depending on which party orders the services. It is specifically understood that in the event SMG ONTARIO is unable to furnish any of the foregoing services resulting from circumstances beyond the control of SMG ONTARIO, then such failure shall not be considered a breach of this Agreement.
- 3.2 Other Services. LICENSEE shall separately pay for all services, equipment, and personnel ("Services") not specifically covered by Paragraph 3.1. SMG ONTARIO shall provide all personnel services in support of the LICENSEE's activities, including but not limited to, emergency medical technicians, door attendants, ticket sellers and takers, dock attendants, security and ushers. Final determination of the number of personnel and the hours worked by the various categories shall be at the discretion

of SMG ONTARIO after consultation with the LICENSEE. LICENSEE shall pay for all event personnel at prevailing rates established and on file in SMG ONTARIO's administrative office. The LICENSEE shall be responsible for making all arrangements with SMG ONTARIO for all program requirements and staffing. Such arrangements shall be coordinated and approved by SMG ONTARIO at least sixty (60) days before the beginning of the term of this Agreement. In the event the LICENSEE fails to do so, then the decision of SMG ONTARIO shall control, and the LICENSEE shall be financially responsible for all charges for such services and equipment so furnished.

- 3.3 Exclusive Services. The following services required by LICENSEE in connection with its Event and/or use of the Licensed Areas, Common Areas or the Facilities shall be provided exclusively by SMG ONTARIO or providers under contract with SMG ONTARIO ("Contract Providers"):
  - Audio/Visual/Telecommunications/Data/Fiber/Internet;
  - Utilities (electrical, water, drainage, etc.)
  - Security;
  - Sound (In-house system);
  - Rigging Points;
  - Food and Beverage/Novelties/Concession Sales/Exhibitor Booth Catering (except novelties and merchandise germane to the Event as explicitly approved in advance by SMG ONTARIO);
  - Business Service Centers in Public Areas;
  - All Common Area Cleaning Services; and
  - Ontario Police personnel and/or Ontario Fire personnel.

LICENSEE shall pay Ancillary Services Fee as established by SMG ONTARIO for services provided by SMG ONTARIO.

PROjection Presentation Technology, Inc. is the exclusive in-house Audio-Visual and Rigging provider of the CENTER. As a full-service company, capable of supplying professional presentation equipment, show management, and creative design, PROjection is the ONLY authorized operator of the CENTER's permanently installed sound system. Should you choose to retain the services of an outside audio-visual supplier, you will be responsible for all equipment and labor costs required to integrate into the house sound system, all associated electrical fees, load-in/load-out liaison hours, and additional buy-out fees dependent upon individual room usage. PROjection is the exclusive rigging provider of the CENTER and no outside rigging provider will be permitted.

- 3.4 <u>Approved Services</u>. LICENSEE may obtain other services it requires from its own providers ("Service Contractors") in accordance with Section 8.4.
- **3.5** Additional Services. SMG ONTARIO may provide other services, equipment, materials, and staffing, upon LICENSEE's request, subject to its Policies, Rules and Regulations and the availability of inventory and staffing. LICENSEE shall pay an Ancillary Services Fee as established by SMG ONTARIO for such additional services.
- 3.6 Concessions and Catering. SMG ONTARIO's caterer, Premier Catering, is the agent of SMG ONTARIO and provides exclusive catering and other services on behalf of SMG ONTARIO, as principal. SMG ONTARIO reserves for itself or its agents, contractors of concessionaires the sole right to the sales and serving of all on-site consumable foods, confections and beverages (alcoholic and nonalcoholic). LICENSEE shall not give away or sell items under the terms of this Agreement without the written permission of SMG ONTARIO. LICENSEE shall pay such rates or fees as SMG ONTARIO shall determine for waiver of SMG ONTARIO's exclusive rights as set forth herein.

In the event the LICENSEE has declined food and beverage service at the time of contract signing and a request for service is made on the day of the event, a minimum service fee of \$100.00 will be charged by SMG ONTARIO. A labor fee of \$100.00 is applicable to all events under 25 people.

3.7 Outside Food and Beverage. No outside food and beverage is allowed.

SECTION 4 POLICIES, RULES AND REGULATIONS; MEDIA RIGHTS; CONDITION OF PROPERTY

- 4.1 Policies, Rules and Regulations.
- LICENSEE agrees to comply with SMG ONTARIO's Policies, Rules and Regulations (collectively "PR&Rs," in existence as of the date of this Agreement or as amended thereafter, all of which are incorporated herein and made a part hereof by this reference) governing the use of the CENTER and acknowledges receipt of a copy of the same. LICENSEE understands these Policies, Rules and Regulations may be amended prior to LICENSEE's Event and agrees to comply with any such amendments. SMG ONTARIO will use its best reasonable efforts to provide written notice to LICENSEE of any such changes, but LICENSEE acknowledges and agrees that it retains the responsibility to keep itself apprised of the current PR&Rs. LICENSEE acknowledges receipt of a copy of the Policies, Rules and Regulations by signing this Agreement.

- (b) LICENSEE shall be solely liable for any and all losses, liabilities, claims, damages and expenses (including reasonable costs of investigation and attorneys' fees) (collectively, the "Losses") occurring at the CENTER (whether within or without the Licensed Areas) caused to SMG ONTARIO, the owner of the CENTER referred to herein as the City of Ontario and/or persons and/or property in, on, or near the CENTER before, during, or after an Event, by (i) LICENSEE's failure to comply with any and all federal, state, foreign, local, and municipal regulations, ordinances, statutes, rules, laws, constitutional provisions, and common laws (collectively, the "Laws") applicable to LICENSEE's performance of this Agreement and/or activities at the CENTER, (ii) any unlawful acts on the part of LICENSEE or its officers, directors, agents, employees, subcontractors, Licensees, or invitees, (iii) the negligent acts, errors and/or omissions or the willful misconduct of LICENSEE or its officers, directors, agents, employees, subcontractors, licensees, or invitees, (iv) the material breach or default by LICENSEE or its officers, directors, agents, or employees of any provisions of this Agreement, including, without limitation, the provisions of Section 4.2 hereof (relating to intellectual property matters), Section 12.12 hereof (relating to the Civil Rights Act), and Section 12.11 hereof (relating to the Americans with Disabilities Act), and (v) any and all rigging from or to the physical structure of the CENTER or any fixture thereto, set-up, alterations, and/or improvements at or to the Facility necessitated by and/or performed with respect to the Event.
- (c) LICENSEE shall conduct business in the CENTER in a dignified and orderly manner with full regard for public safety and in conformity with SMG ONTARIO's General Policies and Regulations, including fire and safety rules as required by SMG ONTARIO and/or local fire regulations, as such may exist from time to time. LICENSEE agrees that it will not allow any officer, agent, employee, Licensee or invitee at, in or about the CENTER who shall, upon reasonable grounds, be objected to by SMG ONTARIO and such person's right to use the CENTER may be revoked immediately by SMG ONTARIO.
- Music Licensing and Intellectual Property. With respect to any Event at the CENTER, LICENSEE shall comply fully with any and all local, state, and federal laws, regulations, rules, constitutional provisions, common laws, and rights of others applicable to the reproduction or performance of proprietary or copyrighted materials and works of third parties (the "Works"), and to the protection of the intellectual property rights associated with such Works. The fees payable by LICENSEE under this Agreement do not include royalty, copyright or other payments which may be payable on behalf of third party owners of such Works, and LICENSEE agrees hereby to make any and all such payments to third parties and/or clearinghouse agencies as may be necessary to lawfully perform, publish or reproduce any such Works. LICENSEE specifically agrees, undertakes, and assumes the responsibility to make any and all reports to such agencies and/or parties, including specifically by way of example only (and not by way of limitation) ASCAP, BMI, SAG, SESAC and other similar agencies. LICENSEE agrees hereby to produce evidence of such reports and payments to SMG ONTARIO, including evidence of compliance with the requirements of this paragraph to be provided to SMG ONTARIO in advance of any such Event. Provision of such evidence is a material condition of this Agreement. LICENSEE agrees to indemnify, defend, protect and hold harmless SMG ONTARIO and all other Indemnitees (as defined in this Agreement) of and from all and all manner of Losses arising in any way from the use by LICENSEE of proprietary intellectual property of third parties (whether such claims are actual or threatened) under the copyright or other laws of the United States. The foregoing indemnity shall apply regardless of the means of publication or performance by LICENSEE, and shall include specifically and without limitation the use of recordings, audio broadcasts, video broadcasts, Works on other magnetic media, sounds or images transmitted via the worldwide web, chat rooms, webcast, or on-line service providers, satellite or cable, and all other publication or performance means whatsoever, whether now known or developed after the date of this Agreement.
- 4.3 <u>Television and Broadcasting Rights.</u> LICENSEE shall not televise or broadcast any Event scheduled to be presented in the Premises or the CENTER under the terms of this Agreement without the prior written approval of SMG ONTARIO. LICENSEE is responsible for obtaining approval and registering for music licensing.
- 4.4 <u>Defacement of Property; Signs and Posters.</u> LICENSEE shall not do, or permit to be done, upon the Premises or the CENTER anything that will tend to injure, mar or in any manner deface the Premises or the CENTER and will not drive or install or permit to be driven or installed any nails, hooks, tacks, or screws into any part of the CENTER, and will not make or allow to be made any alterations of any kind to the buildings or equipment of the CENTER. LICENSEE shall not post or exhibit or allow to be posted or exhibited any signs, advertisements, show bills, lithographs, posters or cards of any description on any part of the CENTER unless relating to the event or exhibition to be given on the Premises and which meet with the approval of SMG ONTARIO. No helium balloons, glitter or confetti are allowed at the Center, the Licensed Areas and the Common Areas or on the premises of the Center.

Notwithstanding anything to the contrary set forth herein, LICENSEE shall be solely responsible and liable for any and all losses arising out of any and all rigging from or to the physical structure of the CENTER or any fixture thereto, set-up, alterations, and/or improvements at or to the CENTER necessitated by and/or performed with respect to the event.

LICENSEE shall pay all costs to return the CENTER to SMG ONTARIO in the same condition as received including but not limited to cleaning, trash dumping, as well as any costs to repair or replace property at the CENTER damaged or lost during the term of this agreement, normal wear and tear excepted, or unless the CENTER or the property at the CENTER are damaged or lost as a result of the sole negligence, gross negligence or willful misconduct of the SMG ONTARIO, its employees or subcontractors. This paragraph also applies to any damages caused by LICENSEE's Service Contractors (see Paragraphs 3.4 and 8.4).

In addition, all consumer shows shall strictly adhere to City of Ontario Municipal Code Section 5, Subsection 1.11, Posting in Public Places. The ordinance reads: "No person shall post, stick, stamp, paint, or otherwise fix, or cause the same to be done by any person, any notice, placard, bill, card, poster, advertisement, or other paper of device calculated to attract the attention of the public to or upon any sidewalk, crosswalk, curb, curbstone, flagstone, or any other portion of part of any public way or public place, or any lamp post or electric light, telegraph, telephone, or trolley line pole, or any railway structure, hydrant, shade tree, or tree box, or upon the piers, columns, trusses, girders, railings, gates, or other parts of any public bridge, viaduct, or other public structure or building, or upon any pole, box, or fixture of the fire alarm or police telegraph system, except such paper or device which may be authorized or required by the laws of the United States, State, or City". If said Municipal Code is not conformed to, then LICENSEE will be assessed a \$2,500.00 penalty to be collected on behalf of the CITY OF ONTARIO Code enforcement by SMG ONTARIO.

#### SECTION 5 INDEMNIFICATION; INSURANCE

- 5.1 <u>Indemnification</u>. LICENSEE shall indemnify, hold harmless and defend the SMG ONTARIO, CITY OF ONTARIO, and their respective members, officers, directors, agents and employees from and against any and all claims, suits, damages, actions, costs, and expenses (including reasonable attorneys' fees) arising out of or connected with, whether directly or indirectly, LICENSEE's operations on or in the Facilities, or the use or occupancy of the Facilities by LICENSEE, its employees, agents, contractors, patrons, guests, exhibitors, licensees, invitees or any other person entering the Facilities with the implied or express permission of LICENSEE, unless the claim or suit arises out of the sole negligence or willful misconduct of the parties to be indemnified, their employees or agents.
- 5.2 Insurance. Notwithstanding the indemnification requirements of Section 5.1, LICENSEE shall, at its sole cost and expense, procure and maintain the following types and limits of insurance, containing the additional insured endorsements and cancellation clause set forth herein. At a minimum, said insurance coverage shall be in effect from 12:01 a.m. on the first day of the License Period to 11:59 p.m. on the last day of the License Period. In the event the License Period is extended, as provided in this Agreement, then the period of coverage shall be extended to cover the extended License Period. LICENSEE shall deliver certificates of insurance evidencing the following coverage and endorsements on or before the date set forth in the Summary of Basic Terms:
- (1) Commercial General Liability policy with coverage as broad as ISO CG0001 in the occurrence form providing coverage against claims for bodily injury or death and property damage occurring in or upon or resulting from LICENSEE's use or occupancy of the Facilities. Such insurance shall be primary and not require contribution from any of the additional insureds other insurance coverages, and shall afford immediate defense and indemnification, as named additional insureds, to SMG ONTARIO, the CITY OF ONTARIO, to the limit of not less than TWO MILLION DOLLARS (\$2,000,000.00);
- (2) Automobile Liability insurance (providing scope of coverage equivalent to ISO policy form CA 0001) with limits of not less than TWO MILLION DOLLARS (\$2,000,000.00) for bodily injury and property damage, in combined or equivalent split limits, for each single accident. Insurance shall cover liability arising out of LICENSEE's use of vehicles in connection with this License Agreement, including owned, leased, hired, and/or non-owned autos, as each may be applicable; and,
  - (3) Worker's Compensation Insurance as required by law.

All insurance policies provided by LICENSEE in satisfaction of this Section 5.2, other than Worker's Compensation insurance, shall include the following additional insured endorsement language:

SMG ONTARIO, LLC, ONTARIO CONVENTION CENTER, CITY OF ONTARIO, AND THE MEMBERS, OFFICERS, DIRECTORS, AGENTS AND EMPLOYEES OF EACH OF THESE THREE ENTITIES ARE NAMED AS ADDITIONAL INSUREDS.

Should any of the above-described policies be cancelled before the expiration date thereof, LICENSEE will promptly provide written notice to the SMG ONTARIO, as soon as LICENSEE becomes aware of the cancellation. If directed by SMG ONTARIO, LICENSEE shall immediately obtain substitute insurance, acceptable to SMG ONTARIO in its sole discretion and evidenced by an appropriate certificate, within ten (10) days of the cancellation, but in no event later than the first (1st) Move-In Date or Start Time. Failure to comply with the insurance requirements herein shall be considered a material breach of this Agreement.

The LICENSEE and SMG ONTARIO agree, and LICENSEE understands that the specified coverage or limits of insurance in no way limits the liability of the LICENSEE. LICENSEE shall maintain, with respect to each such policy or agreement, evidence of such insurance coverage and endorsements required by this Agreement.

5.3 Failure to Provide Proof of Insurance. In the event LICENSEE fails to provide the required certificates of insurance by the due dates, SMG ONTARIO shall have the right to cause policies meeting the requirements of this section to be issued in LICENSEE's name and the premiums for such insurance shall be payable by LICENSEE to SMG ONTARIO as an Ancillary Services Fee in accordance with Section 2.2 of this Agreement.

SECTION 6 BREACH; RIGHT TO CURE; REMEDIES

Page 6 of 11
Initial:

In the event LICENSEE fails to perform or comply with any of the material covenants or provisions of this Agreement, SMG ONTARIO shall provide LICENSEE written notice to cure the default within a commercially reasonable time, as determined by SMG ONTARIO, except notice and time to cure shall not be required when the breach involves public safety, immediate waste or damage to the Facilities or SMG ONTARIO's equipment. If LICENSEE fails to timely cure the default or if the breach involves public safety or property damage or waste, SMG ONTARIO shall have the right, without further notice, to invoke any or all of the following remedies:

- (1)Require and retain additional security for LICENSEE at LICENSEE'S expense;
- (2)Terminate this Agreement and revoke the License granted hereunder;
- (3)Enter and take possession of the Licensed Areas and remove all persons and property, without instituting any legal proceedings;
- (4)Withhold all payments made to SMG ONTARIO and apply the same to offset SMG ONTARIO's compensatory or liquidated damages; and,
- (5)Institute legal proceedings to recover damages. **SECTION 7 CANCELLATION** LICENSEE; LIQUIDATED DAMAGES; FORCE MAJEURE
- 7.1 Cancellation; Liquidated Damages. If LICENSEE cancels it's Event, its use of some portion of the Licensed Areas, some portion of its License Periods, or terminates this Agreement for any reason other than those set forth in Section 7.2, deposits paid shall be forfeited and applied to offset SMG ONTARIO's Liquidated Damages as provided herein. The LICENSEE and SMG ONTARIO agree that the damages to SMG ONTARIO resulting from cancellation of the Event or any portion of the Licensed Areas or License Periods, or termination of this Agreement, would be extremely difficult to determine because of the loss of revenue from ancillary and other services anticipated by this Agreement. Because of this difficulty in determining the resulting damages, the LICENSEE and SMG ONTARIO agree that, in the event of cancellation or termination, LICENSEE shall pay to SMG ONTARIO Liquidated Damages in the amount set forth below as determined by the type of cancellation and the proximity of the cancellation date to the Event Move-In date. LICENSEE agrees to pay the Liquidated Damages to SMG ONTARIO within thirty (30) days of written notice of cancellation.

- Force Majeure. If the CENTER is damaged from any cause whatsoever or if any other casualty or unforeseeable 7.2 cause beyond the control of the parties, including, without limitation, acts of God, fires, floods, epidemics, quarantine restrictions imposed by government officials, terrorist acts, strikes or labor disputes (though not of the employees of the LICENSEE), failure of public utilities, or unusually severe weather, prevents occupancy and use, or either, as granted in this Agreement, then the parties shall be relieved of their respective obligations hereunder. In the event performance is excused in accordance with the foregoing provisions, SMG ONTARIO shall refund to LICENSEE any deposits paid by LICENSEE, less any reasonable costs and expenses which have been incurred by SMG ONTARIO up to the time further performance is excused. SECTION 8 LICENSEE'S **OBLIGATIONS**
- 8.1 LICENSEE shall have the right to inspect the Facilities and the Licensed Areas prior to executing this agreement to determine that they are reasonably suited for the uses contemplated by LICENSEE. LICENSEE shall have the right to a joint inspection prior to and after the License Period to assess the condition of the Facilities and the Licensed Areas and to determine damage, if any, resulting from LICENSEE's activities. SMG ONTARIO warrants that the Facilities and Licensed Areas will be in a suitable condition for the uses contemplated by the LICENSEE during the Licensed Periods.
- 8.2 Compliance with Laws. Each party shall promptly comply and cause its agents, servants, employees, contractors, patrons, guests, licensees or invitees to promptly comply with all applicable laws, ordinances, rules, and regulations of all federal, state, county and city governments, departments, commissions, boards and officers.
- 8.3 Licenses and Permits. LICENSEE shall obtain any licenses and permits required by federal, state, county, or city laws and shall permit inspection by appropriate agencies or departments.
- Subject to Section 3, at least sixty (60) days prior to the beginning of License Period, Service Contractors. LICENSEE shall submit to SMG ONTARIO a list of all persons or entities who will provide a service to or on behalf of LICENSEE during the License Period (herein "Service Contractors"). SMG ONTARIO may require its approval of certain Service Contractors prior to services being rendered.

- 8.5 Non-discrimination. LICENSEE acknowledges and understands that SMG ONTARIO has a comprehensive policy of non-discrimination in all aspects of its business activities. LICENSEE agrees that, in connection with its Event and its use of the Facilities and Licensed Areas, neither LICENSEE, nor its agents, employees, exhibitors or contractors, shall discriminate against any person with respect to employment, contracting, admission, or services or privileges offered to attendees of LICENSEE's Event, in violation of federal, state or local laws.
- 8.6 Payment of Taxes. LICENSEE acknowledges and understands that state and/or local taxing authorities may impose a tax or other assessment on LICENSEE's use of the Facilities (a possessory use tax) and that LICENSEE shall be solely liable for payment of this, and any other taxes levied on its use of the Facilities.
- 8.7 Sale of Novelties and Merchandise Notwithstanding. SMG ONTARIO retains exclusive rights with respect to the sale of novelties and merchandise. LICENSEE may distribute or sell items that are specifically germane to the nature or purpose of LICENSEE or its Event, as determined and approved with prior written consent by SMG ONTARIO.
- 8.8 Complimentary Tickets. Licensee agrees to provide SMG Ontario with 50 complimentary tickets no later than 3 days prior to the start of the event. (Tickets will be given to your Event Manager). These tickets will be distributed by the Executive Management of the CENTER for use by SMG Ontario clients, CITY OF ONTARIO officials, staff and guests. SECTION 9 RIGHT OF ENTRY; EJECTION OF DISORDERLY PERSONS; SECURITY
- SMG ONTARIO's Right of Entry and Control. The CENTER, the Facilities, including the Licensed Areas, shall at all times be under the charge and control of SMG ONTARIO, whose duly authorized representatives shall have unfettered access to, and the right to enter, all areas in the Facilities including the Licensed Areas at any time, provided such entry does not interfere with LICENSEE's use. The SMG ONTARIO's duly authorized representatives also shall have the unfettered right to inspect the Licensed Areas at any time to ensure that LICENSEE's use of such areas is in accordance with this Agreement and the rules and policies applicable to the Facilities. In the event that the SMG ONTARIO determines that LICENSEE is violating the Agreement or such Policy, Rules and Regulations (see paragraph 4.1 above), SMG ONTARIO shall have the right to terminate this Agreement in its sole discretion, or alternatively, to require LICENSEE to come into compliance within a period of time to be determined by the SMG ONTARIO in its sole discretion.
- 9.2 Ejection of Disorderly Persons. All persons associated with LICENSEE's event including but not limited to attendees, guests, exhibitors/vendors, and Service Contractors must adhere to the CENTER's Policy, Rules and Regulations. SMG ONTARIO shall have the right to refuse entrance to, or remove and eject from the Facilities, any person associated with LICENSEE or present at LICENSEE's Event whose conduct is objectionable, disorderly, disruptive, or in violation of any law. The indemnification provisions of this Agreement shall apply to any claim or cause of action arising from such ejectment.
- 9.3 Security Levels. SMG ONTARIO shall be the sole provider of security in the CENTER, loading dock areas and for the facility perimeter. LICENSEE may be required to contract for event security staffing or with the Ontario Police within Licensed Space. SMG ONTARIO shall have the sole right to determine the minimum level of all security required for LICENSEE'S Event. All security and staffing plans must be submitted to the SMG ONTARIO at least sixty (60) days in advance for approval. SECTION 10 REPRESENTATIONS AND WARRANTIES

SMG ONTARIO and LICENSEE hereby represents and warrants to the other party, and agrees as follows:

- (a) It has the full power and authority to enter into this Agreement and perform each of its obligations hereunder;
- It is legally authorized and has obtained all necessary regulatory approvals for the execution, delivery, and (b) performance of this Agreement; and
- No litigation or pending or threatened claims of litigation exist which do or might adversely affect its ability to fully perform its obligations hereunder or the rights granted by it to the other Party under this Agreement. SECTION 11 COVENANTS

LICENSEE hereby covenants as follows:

- (a) LICENSEE shall not occupy or use the CENTER except as provided in this Agreement.
- LICENSEE shall comply with all legal requirements which arise in respect of the use of the CENTER, as well as the use and occupation thereof.
- LICENSEE shall not cause or permit any Hazardous Material to be used, stored, or generated on, or transported to and from the CENTER and its premises. "Hazardous Material" shall mean, without limitation, those substances included within the definitions of "hazardous substances", "hazardous materials", "toxic substances", or "solid waste" in any applicable state or federal environmental law.

- (d) LICENSEE shall not broadcast by television or radio any Event scheduled to be presented in the CENTER and the Licensed Areas under the terms of this Agreement without the prior written approval of SMG ONTARIO.
- (e) LICENSEE shall not cause or permit food or beverage, beer, wine, or liquors of any kind to be sold, given away, or used upon the CENTER and the Licensed Areas except upon prior written permission of SMG ONTARIO.
- (f) LICENSEE shall not operate any equipment or materials belonging to SMG ONTARIO without the prior written approval of SMG ONTARIO.
- (g) No portion of any passageway or exit shall be blocked or obstructed in any manner whatsoever, and no exit door or any exit shall be locked, blocked, or bolted while the CENTER and the Licensed Areas are in use. Moreover, all designated exit ways shall be maintained in such manner as to be visible at all times.
- (h) LICENSEE shall not encumber, hypothecate, or otherwise use as security its interests in this Agreement for any purpose whatsoever without the express written consent of SMG ONTARIO.
- (i) LICENSEE shall not engage in the sale and/or distribution of food and/or beverages at the CENTER without the express written consent of SMG ONTARIO.
- (j) LICENSEE shall use the CENTER and its logo (the "Center's Logo") in all advertising controlled by or done on behalf of LICENSEE relating to an Event, including, but not limited to, television, internet, newspaper, magazine, and outdoor advertising. LICENSEE's right to use the Center's Logo shall be limited to the specific, express purpose set forth in the foregoing sentence and/or as otherwise authorized by SMG ONTARIO in writing prior to the use thereof. In connection with LICENSEE's use of the Center's Logo as permitted in this Agreement, LICENSEE shall use only the form of the Center's Logo as provided by SMG ONTARIO to LICENSEE in any artwork or other depiction thereof. **SECTION 12**GENERAL PROVISIONS
- 12.1 <u>Vacation of Premises</u>. In the event that the Premises or any portion thereof is not vacated by LICENSEE at the end of the periods set forth herein, then SMG ONTARIO shall be and is hereby authorized to move from the Premises, at the expense of the LICENSEE, any and all goods, wares, merchandise and property, of any and all kinds of description, which may be then occupying the Premises, or portion thereof which is not timely vacated; and SMG ONTARIO shall not be liable for any damages or loss to said goods, wares, merchandise or other property which may be sustained, either by reason of such removal, or the place to which it may be removed, and SMG ONTARIO is hereby expressly released from any and all claims for damages. For such additional period between the Term or License Period set forth herein, if any effects of LICENSEE or their exhibitors remain in or on the Premises, SMG ONTARIO shall be entitled to charge the sum per day as damages, as provided in the Summary of Basic Terms.
- 12.2 Abandoned Equipment and Lost or Misplaced Articles. Any equipment or personal property belonging to LICENSEE or its agents, servants, employees, contractors, invitees, patrons, guests, vendors, which remains in the Facilities or the Licensed Areas after the License Period, shall be deemed abandoned and may be disposed of by SMG ONTARIO at LICENSEE's sole expense. SMG ONTARIO shall assume no responsibility for losses caused by theft, disappearance or abandonment of equipment or personal property.
- 12.3 <u>Non-Exclusive Right</u>. SMG ONTARIO retains the right to use and/or license use of such portions of the CENTER as are not licensed by this Agreement. SMG ONTARIO warrants however, that it will not authorize or permit any other licensee to engage in operations or activities that would interfere with LICENSEE's enjoyment of the rights granted under this License.
- 12.4 Advertising. LICENSEE agrees not to allow any advertising media, in advertising the Event for which LICENSEE is granted this License, to imply that SMG ONTARIO is sponsoring such Event or is in fact cosponsored by SMG ONTARIO unless agreed to in writing by SMG ONTARIO. LICENSEE agrees that all advertising of the Event will be honest and true, and will include accurate information. If the Ontario Convention Center's logo, photo and or name are used, prior written approval from SMG ONTARIO must be obtained before final printing.
- 12.5 <u>Interruption or Termination of the Event.</u> SMG ONTARIO retains the right to cause the interruption of the Event in the interest of public order or safety; and to likewise cause the termination of the Event when, in the sole judgment of SMG ONTARIO, such act is necessary in the interest of public order or safety. LICENSEE hereby waives any claim for damages or compensation should this Agreement be so terminated.
- 12.6 Applicable Law, Venue and Jurisdiction. This Agreement shall be governed by and construed in accordance with California law. Any action by a party to this Agreement to enforce or interpret the terms hereof shall be maintained in the San Bernardino County Superior Court or the Federal District Court for the Central District of California. LICENSEE consents to the foregoing and agrees that this Agreement has been entered into in the State of California which constitutes sufficient minimum contacts with SMG ONTARIO to permit the Courts of California to assert jurisdiction over LICENSEE in any action brought by SMG ONTARIO.

- 12.7 <u>Attorneys' Fees.</u> The prevailing party in any action or proceeding brought to enforce or interpret any provision of this Agreement or to recover damages resulting from breach shall be awarded reasonable attorneys' fees, court costs, in addition to any other similar compensation.
- 12.8 <u>Delivery of Notices</u>. Subject to any provision to the contrary, any statement, notice, request, demand, consent or approval under this Agreement must be in writing and personally delivered, sent via email, sent by overnight courier service, or sent by United States registered or certified mail, postage prepaid, return receipt requested and shall be deemed to have been given upon the date of personal delivery, the date the email was sent by sender, the next business day following deposit with an overnight courier or five (5) days after deposit in the United States mail, provided that in the case of communications sent by overnight courier service or United States registered or certified mail, the communication is addressed to the respective parties at the following addresses (either party may, by written notice, designate a different address):

- **12.9** Partial Invalidity. If any provision of this Agreement is declared invalid or unenforceable, the remaining provisions shall continue in full force and effect to the fullest extent permitted by law.
- 12.10 <u>Assignment; Subletting Licensed Areas</u>. LICENSEE shall not assign this Agreement or any interest herein or permit the use of the Licensed Areas or any part thereof by any other party, except that LICENSEE shall have the right to permit its exhibitors to use the Licensed Areas in conjunction with LICENSEE's Event. Any substantive change in the nature of LICENSEE's Event, without SMG ONTARIO's prior written consent, shall constitute a material breach of this Agreement.
- 12.11 Americans with Disabilities Act (ADA). LICENSEE acknowledges it is responsible for complying with ADA non-permanent accessibility requirements such as, but not limited to, accessibility of non-permanent seating and auxiliary aids for the visually impaired, hearing impaired and mobility impaired. No charge shall be made by LICENSEE or the CENTER to any person requiring such aids or services.
- 12.12 <u>Civil Rights Act.</u> During the performance of this Agreement, LICENSEE shall comply fully with Title VI and Title VII of the Civil Rights Act of 1964, as amended, and all other regulations promulgated thereunder, in addition to all applicable state and local ordinances concerning Civil Rights.
- 12.13 Right to Quiet Enjoyment. SMG ONTARIO warrants that the Licensed Areas shall be operational and free from any substantial interference or disturbance directly related to any construction work on the Facilities. In the event construction causes a substantial interference with LICENSEE's Event, SMG ONTARIO shall use its best efforts to mitigate any disruption. In no event, however, will SMG ONTARIO be liable for any consequential damages to LICENSEE, including claims for lost or reduced income resulting from the interference or disturbance. SMG ONTARIO's liability, if any, shall be limited to a return of the License Fee for any period of time that LICENSEE is unable to use the Licensed Areas because of the interference or disturbance.

- 12.16 Patent. LICENSEE assumes all costs arising from the use of patented, trademarked, or copyrighted materials, equipment devises, processes or dramatic rights used or incorporated in the conduct of any event covered under a permit; and the LICENSEE agrees to indemnify and hold harmless SMG ONTARIO from all damages, costs and expenses in law and equity for or on account of any patented, trademarked or copyrighted materials, equipment, devices, processes or dramatic rights furnished or used by the LICENSEE, or its performers or exhibitors in connection with the Agreement and will defend SMG ONTARIO from any such suit or action, whether it be groundless or fraudulent.

- 12.17 <u>Food Sampling.</u> Free samples are limited to two (2) ounces of non-alcoholic beverage and one (1) ounce of food to comply with code. Exact descriptions of sample and portion size must be submitted to the CENTER for written approval at least 14 days prior to your event. A Department of Health Permit and other permitting may be required.
- 12.18 <u>Counterparts; Facsimile or Scanned Signatures</u>. This Agreement may be signed in counterparts, and the counterparts taken together shall be deemed an original executed Agreement. A signature may be delivered to the parties by fax or scanned and e-mailed document, and such fax or scanned signature shall be accepted and effective as an original signature.
- 12.19 <u>Effective Date of Agreement.</u> The effective date of this Agreement shall be the date it is executed by SMG ONTARIO.

#### Some common additional costs to keep in mind when planning your event

Air Wall Opening and Closing: Changes in configuration of the moveable walls are subject to a charge of \$250.00.

Audio Visual: Projection Presentation Technology is our exclusive in-house Audio Visual provider and is exclusive to all rigging. All cables must be flown and taped properly. Additional rigging fees for lift(s) and points may apply. (Electrical not included.)

Crowd Control (Ushers): Crowd control is required at an additional cost regardless of number of attendees. \$21.75 / hour (4 hour minimum).

Deviation to Contracted Hours: A minimum of \$450.00 per hour plus \$200.00 labor fee will apply for any deviations to contracted hours plus O/T if required.

Dock: Any activity openedin the form of exhibitors, load in and deliveries require dock attendant(s) at all times to monitor traffic. \$21.75 / hour (4 hour minimum).

EMT: All events at the facility that have 400 attendees or more must have an Emergency Medical Technician (EMT) on-site thru OCC's exclusive contractor. Depending on the nature of the event and other events less than 400 attendees may also be required to provide medical services. Rate for EMT service is \$69.00 / hour (6 hour minimum).

Event Security: Required for any type of high risk event or cash handling. Rate is \$34.00 / hour for an unarmed guard and \$300.00 / hour (2) OPD armed police (6 hour minimum).

Fire Beam Limitations: Helium balloons, fog machines, hazers, smoke and candles must be coordinated in advance with your Event Manager. Fire watch fee of \$110.00 / hour is required with a 6 hour minimum. See fire standards requirements.

Food and Beverage Services: Provided exclusively by Ontario Convention Center. No Outside Food and Beverage is allowed at any time inside or outside the facility. Please coordinate all food and beverage needs with your Catering Manager in advance. No picnicking is allowed in the parking lots or surrounding businesses.

Housekeeping: Based on the type of event, pre-event, event and post-event cleaning fees with trash haul and roll off. Dumpster for Exhibits.

Insurance: All Licensees and their sub-contractors are required to provide a Certificate of Insurance for entire contract, event and move-in/move-out days; insurance coverage may be purchased through the Center's insurance program @ \$1.50 per person / per day (high risk at prevailing rates). Minimum \$150.00.

**Keys:** The Convention Center has the capability to change door locks on designated rooms for a fee (contact your Event Manager for associated fees). Request for keys should be made through the Event Manager and all keys must be returned on the last day of the event.

Parking: Current automobile parking fees are up to \$15.00 per car per day. No in and out privileges. No overnight parking allowed.

Police: Ontario Police Department reserves the right to require police officers as deemed necessary at \$155.00 / hour (6 hour minimum per officer, 2 officer minimum).

Room Changeovers: Licensor offers one set-up per event. Any changes to the set-up on the day of event or overnight will incur a (minimum) labor fee of \$250.00 per change per meeting room. Ballroom & Ex Halls based on change.

Shipping: Freight or materials (including overnight freight services) are not accepted prior to contracted move-in date. If items need to be shipped, please fill out the service storage order form and items can be stored early for a fee. No perishable storage.

**Utilities:** Electrical, telecom or other utility services are provided exclusively by the Center at prevailing rates. Air conditioning or heating will not be turned on for any move-in/out days unless purchased in advance. See attached <u>Electrical service order</u> for additional information.

Wi-Fi: The Center has wireless internet available throughout the building for an associated fee. Logging onto our guest wireless network will walk you through the process.

The above information, along with the Center's <u>Rules and Regulations</u>, are intended to help you plan and budget for services you may require. Prices and policies are subject to change (please ask your Event Manager to prepare an event cost estimate before establishing final budgets).



#### **Rules and Regulations**

The following information is provided to assist in the planning of your event and outlines services available through the Ontario Convention Center (OCC) and its Contractors. Also listed are building policies to be aware of. If you have any questions regarding any of this information, please contact us for further details. Please see the No Surprise List for additional information.

#### ABANDONMENT OF GOODS

The Ontario Convention Center (OCC) is not responsible for damage and or loss of any item(s) left behind by the Show Manager, its representatives or exhibitors upon move out of the facility. If OCC recovers the item(s) and the Show Manager advises OCC that the item(s) need to be returned, a shipping charge may be applicable. In the event the Show Manager does not advise OCC of the item(s) left behind, OCC reserves the right to dispose of the item(s) as deemed necessary.

#### ADA COMPLIANCE

The Ontario Convention Center (OCC) provides permanent access accommodations under the guidance of the Americans with Disabilities Act (ADA). When planning your event, we ask that you provide accessibility to all individuals for exhibits, displays, meetings, etc. with respect to set up, location, path of travel and other aspects of the event. Please also provide any temporary auxiliary aids and services required for disabled attendees under the guidance of the ADA. Wheelchairs are not available onsite at the OCC; however, you may coordinate in advance through the Service Desk (909) 937-3068.

#### ADVERTISING / SIGNAGE

All off-site, outdoor advertising within the City limits requires approval from the City of Ontario. Please contact your Event Manager for questions. The posting of signs, advertisements, show bills, lithographs, posters or cards is not permitted in or on any part of the OCC premises without prior permission. All unauthorized signage will be removed.

#### **ANIMALS**

No pets allowed except for service animals. For events that may include animals, please contact the San Bernardino Health Department for additional information.

#### ARMED GUARD

Armed guards are exclusive and contracted through OCC. Based upon the type of event, armed guards are required whenever money is handled including any locations accepting monetary offerings for the event. See Security for more information.

#### **ATM LOCATION**

For your convenience, three (3) ATM machines are located in the main hallway in the North and South Lobby.

#### AUDIO VISUAL (A/V)

The Ontario Convention Center has selected Projection Presentation Technology as the exclusive Audio Visual partner provider. Projection Presentation Technology provides a full inventory of State of the Art Audio Visual equipment. Additionally, the company provides a wide array of Professional Audio Visual Management services and professionally trained technicians. For contracted events that must utilize their own staff and owned inventory or are traveling with their partnered Production Company, a charge of \$350.00 per meeting room, \$500.00 per Ballroom and \$750.00 per Exhibit Hall/per day will apply (subject to change). In addition, a load-in and load-out liaison, hourly labor charge with a five (5) hour minimum will be required. Also, any such circumstance which

requires the Ontario Convention Center to permit outside Audio Visual regardless of monetary amount or quantity of equipment will require \$2 Million Liability coverage provided prior to event start date. Any on call needs will be charged at double-time to help facilitate unscheduled labor not anticipated. As with all groups, the Guidelines outlined in the Ontario Convention Center's Rules & Regulations for Safety must be adhered to. Lastly, all outside Audio Visual services must obtain approval from the Ontario Convention Center and Projection Presentation Technology. We will be glad to provide a competitive price quote and comprehensive proposal based on your needs. All Rigging Equipment and Labor remains the exclusive domain of Projection Presentation Technology.

Projection is exclusive for rigging. See Rigging for additional information. Please contact a Projection representative at 909-937-3072 to discuss your audio visual needs.

#### BANNERS / DECORATIONS/BALLOONS

All interior banners, with the exception of tradeshow/exhibit hangings, must be hung by OCC personnel. Arrangements for interior banner hanging should be made in advance through your Event Manager a minimum of sixty (60) days prior to your event. All exterior banners require advance approval from the City of Ontario Planning Department and arrangements should be made a minimum of sixty (60) days prior to your event. Decorations, banners and similar displays may not be fastened to ceilings, painted surfaces, wall coverings, air walls, columns or doors. Please contact your Event Manager for clarification or special requests. All props, table coverings, drapes, etc., must meet fire code regulations, be approved in advance as part of the floor plan and have any required fire certifications. Adhesive backed decals and stickers may not be used or distributed without written consent of the OCC. Helium balloons, glitter and confetti cannons are not permitted.

#### **BOX OFFICE**

The box office must be utilized for all cash sales. Box office rental is \$300.00 per unit and includes electrical, lighting, air conditioning and heating. Armed security is mandatory for all box office events and/or whenever money is handled. See Armed Guard section for more information. Box office personnel such as Box Office Manager and Ticket Sellers are available at an additional cost. All personnel are required thirty (30) minutes prior to the box office opening and after closing times. Show Managers will be responsible for all event ticket refunds and any related costs.

#### BUS SHUTTLE / DROP-OFF AREA

Drop-off and pick-up location is located on the east side of the building, adjacent to parking Lot A.

#### CATERING/CONCESSIONS

See Food and Beverage for details.

#### **CLEANING**

The contracted areas of the OCC will be provided to you in clean condition. During your event, the OCC Operations Staff will maintain all public areas and meeting spaces except when said areas are utilized as exhibit space and are the responsibility of the Tradeshow Contractor. As an optional service, the OCC can provide show cleaning services at a fee.

#### **CONTRACT DECORATORS**

Your Event Manager can provide a list of Decorators or OCC can assist with your event needs. All sub-contractors must adhere to OCC's sub-contractors rules and regulations, must be insured and sign the OCC's <u>Contractor's Guidelines</u>.

#### **CREDENTIALS**

All service contractors and show related working personnel, temporary labor, etc., should enter and exit the OCC through designated entrances and must wear proper identification credentials.

#### CROWD CONTROL (USHERS) / SAFETY (EXCLUSIVE)

Crowd Control is required at additional cost regardless of number of attendees. Crowd Control is generally required any time the doors are open to the public or during move-in/out. Crowd Control consists of the ushers' supervisor,

door ushers, and directional ushers for emergency or event activities. Crowd Control personnel are required at a minimum of one half hour prior to the doors opening and will be released by the Event Manager at the conclusion of the event. A ratio of at least 1 usher per 250 adults and 1 usher per 150 children (17 and under) is recommended; some events may require more. Should the event involve children activities and/ or childcare rooms, additional Crowd Control personnel will be required. A meeting regarding children's safety and a plan of action must be scheduled between show management, staff (volunteers) who work with the children and facility staff including but not limited to Event Managers, Security Supervisors, and Crowd Control Supervisors at least seven (7) days prior to the first event day.

#### **DAMAGES**

The OCC will make every effort to inform you of any damages as soon as they are discovered. We ask that any damage(s) you notice be reported immediately to an OCC staff member. If any portions of the premises or furnishings are damaged through the negligence or fault of the Licensee, its agents, or guests, Licensee will be responsible for any cost associated to return the area(s) to its original condition.

#### DOCK ATTENDANTS (EXCLUSIVE)

One (1) dock attendant is required anytime the dock is open and when heavy equipment is operational in the dock area; two (2) dock attendants are required for up to 25 booths; three (3) dock attendants are required for 26-100 booths; (4) dock attendants are required for more than 100 booths. Dock attendants are required during the exhibitor/decorator move-in times at a minimum of thirty (30) minutes prior and thirty (30) minutes after move-in times. No move-in vehicles may be left parked in the dock area. Exhibitor/ Decorator have forty five (45) minutes to load and unload in the dock area. Vehicles must move after that time or they will be towed.

#### ELECTRICAL / UTILITIES FOR SHOW MANAGER (EXCLUSIVE)

House lighting, ventilation, heat or air conditioning will be provided as required during show open times. Energy conservation and sustainability practices are very important to OCC and minimal light and temperature levels will be maintained during move-in / move-out hours. Rehearsals and similar pre-event activities may be assessed a utility charge for special light and temperature levels. Only authorized OCC staff may access electrical, water (fill, drain and water key) and telecommunications equipment. All usage of the utility services must be approved in advance by the OCC. Notify your Event Manager of your requirements. Please reference Utilities Form.

#### ELECTRICAL / UTILITIES FOR VENDORS / EXHIBITORS (EXCLUSIVE)

All exhibitors lighting and electrical must be turned off during non-operating hours. Only authorized OCC staff may access electrical, water (fill, drain and water key) and telecommunications equipment. All usage of the utility services must be approved in advance by the OCC. Exhibitor electrical and utility services will be provided by OCC. Contact the Service Desk for assistance at 909-937-3068 / <a href="mailto:servicedesk@ontariocc.org">servicedesk@ontariocc.org</a>. #### EMERGENCY MEDICAL TECHNICIAN (EMT) / FIRST AID (EXCLUSIVE)

All events at the facility with four hundred (400) attendees or more must have an Emergency Medical Technician (EMT) onsite through OCC's exclusive contractor. Depending on the nature of the event, other events with less than four hundred (400) attendees may also be required to provide medical services. Please make arrangements for Emergency Medical Services with your Event Manager thirty (30) days prior to your event. The EMT is located inside the First Aid room in the South Lobby.

#### **EOUIPMENT INVENTORY AND RATES**

Equipment is available based on inventory. The OCC will make every effort to accommodate the needs of our guests. The rates listed are subject to change; please consult with your Event Manager for current information. The costs for supplemental equipment will vary based on quantity and availability. If you have special requests for furnishings outside of our inventory, the Event Manager will assist in making arrangements to secure the equipment at current rates.

#### FIREARMS DEACTIVATION AND SAFETY FOR EXHIBITS

Breech-loading firearms displayed must be deactivated by removal of the firing pin or other alteration so that they may not be fired. Live ammunition, powder or primers may not be brought into the building. Exceptions may be granted by OCC Management for particularly rare antique firearms or ammunition displayed in locked display cases or otherwise made inaccessible. Firearms will be inspected before the show by an authorized safety advisor. Infractions will be reported to both Exhibitor and Show Management. All infractions must be corrected before the exhibit will be allowed to open. Over the counter sales of firearms and ammunition are not permitted; however, exhibitors may take orders for future delivery. Gun shows are permissible providing the producer is bona fide and state permitted, in which case all federal and state regulations prevail and must be strictly adhered to.

#### FIRE MARSHAL SERVICES (EXCLUSIVE)

Fire Marshal presence is **required** during your event under the following circumstances: Use of candles, smoke, fog or hazer's (hazer liquid must be water based, no oil based substances are permitted) and whenever a significant life/safety issue is deemed to be present. Your Event Manager will make arrangements for Fire Marshal presence based on an evaluation of your event characteristics. Please reference <u>Fire Checklist</u>.

#### FLOORPLAN / VEHICLE DISPLAY APPROVAL

All vehicles on display must have less than 1/4 of a tank of gas, batteries are disconnected, locked or taped gas cap and an oil pan under the vehicle. Approval by Ontario Fire Department is required on all floor plans. Each promoter/show manager that contracts for exhibit space must submit detailed event diagrams to their Event Manager and contact the Ontario Fire Department at 909-395-2562 to purchase the Exhibit Trade Show Permit. North & South configuration is required for the Exhibit Halls. Blocking concessions is subject to a food buyout.

#### **FLOOR PROTECTION**

You must place visqueen, (at least 4ml thick), or masonite on all carpeted and terrazzo areas during load in and load out when using lifts, pallet jacks and/or other related equipment. Lifts carrying freight may not travel across terrazzo or carpeted surfaces; although limited exceptions may be pre-approved for light equipment with appropriate tire protection. Gaffers tape is the only tape approved for use on carpeted and terrazzo areas. Chalk, duct tape, masking tape or other unapproved tape is not permitted. Licensee will be responsible for any and all damage to the carpet or tiles during the load in/load out process. Concrete and terrazzo floor must not be scuffed or scratched by moving equipment. Applicable charges will apply.

#### FOOD & BEVERAGE / CATERING (EXCLUSIVE)

Outside food or beverages are not permitted on OCC property. All food services are exclusive through OCC. No tailgating in the parking lots of OCC and or the surrounding supporting lots. Consumables that are to be given to attendees free of charge must be pre-approved with OCC's Catering Department. Distribution or sale of food or beverages including but not limited to snacks in children's activities and /or childcare room; from sources other than OCC's Catering Department is strictly prohibited. Violation of such policy will result in the interruption of event and /or additional penalty to the Show Manager. Selling, distribution and consumption of all alcoholic beverages must be in accordance with the laws, statutes and regulations of the State of California. The State of California has issued an Alcohol Beverage Control (ABC) license to OCC for their exclusive sale and distribution of alcoholic beverages. The ABC license precludes the dispensing of alcoholic beverages to individuals under the age of 21. Licensee will be responsible for assistance in preventing any consumption of alcoholic beverages by underage attendees and to provide security as required by the OCC. OCC reserves for itself or its agents, contractors of concessionaires the sole right to the following services: sales and serving of all on-site consumable foods, confections and beverages (alcoholic and non-alcoholic), parking and sales of all souvenirs and novelties, programs

and other merchandise; subject to merchant buyout. Contact the Catering Department to arrange all snacks, food and beverage at 909-937-3061.

#### **FORKLIFT**

See Lifts and Storage for details.

#### **FREIGHT ELEVATOR**

All carts and heavy equipment loading into the second floor meeting room space must use the freight elevator located in the breezeway near the dock. Freight elevator is 8'W x 7'H x 11'L.

#### **HOURS**

OCC administrative offices are open during regular business hours, Monday through Friday 8:00AM-5:00PM, excluding holidays. Hours of use for contracted space are outlined during contracting with your Sales Manager and will be finalized prior to arrival with your Event Manager. Changes may be made to your program, once on-site and depending on length of notice, applicable overtime or labor charges may apply. Administrative Office phone number is 800-455-5755 or 909-937-3000.

#### **HOUSE LIGHTING**

House lighting will not be used as entertainment lighting. House lights may be dimmed to 33% for safety. Two set configurations are included. Additional changes are available for an additional fee. Contact the Event Manager for more details.

#### INSURANCE

All clients and sub-contractors must provide a Certificate of Liability Insurance form for \$1M in General Liability coverage and an Additional Insured Endorsement form that specifies and includes the Ontario Convention Center, SMG and City of Ontario entities. Both insurance documents must be received one week prior to the move-in date. High-risk events such as sporting, fighting, racing, those groups using their own Audio Visual and as specified by OCC must provide \$2M in General Liability insurance coverage. Please reference Insurance Checklist.

#### IT / TELECOM

OCC is exclusive for all IT and telecom needs. OCC's full-range of technical services is linked through thirty (30) miles of fiber optic cabling. Available telecom services include general phone services, VOIP, multi-mode and single-mode fiber optic connectors, category-5 wiring with RJ-45 connectors, webinars and webcasting. Internet services include access from any location in the center, both wired and wireless and network (LAN) in any part of the center. Please contact the Event Manager with your requirements. All exhibitor/vendor requests must be submitted through our Service Desk at 909-937-3068 or <a href="mailto:servicedesk@ontariocc.org">servicedesk@ontariocc.org</a> Please reference <a href="mailto:Telecom">Telecom</a> Form.

#### KEYS/ROOM SECURITY

Should you request a "re-key" on any of the meeting room doors, a \$150.00 charge per door will apply which includes one (1) key. Additional keys are available at \$15.00 each. Lost re-keys will be subject to a \$30.00 fee.

#### LIFTS AND LIFT STORAGE

If a lift is required, arrangements should be made in advance with your Event Manager. OCC lifts may only be operated by OCC employees. The floor weight load limit is 125 psi for the first floor and 100 psi for the second floor. OCC staff will locate and uncover the floor boxes in order to avoid them as the weight of the lift may cause damage. If wheels are not "non-marking and / or black rubber", they must be covered before entering the facility to prevent carpet damage. If the aisles are covered with visqueen and / or masonite, tire wrapping of equipment is not required.

#### LOADING DOCK

An 8-bay loading dock is located on the west end of the building and affords easy access to the Exhibit Halls. Two roll up doors are 14' high and 20' wide. To maintain safe and efficient operations, the Event Manger shall assign

dock attendants to assist with traffic coordination during load in and load out. All basic safety rules and OSHA guidelines are to be followed during load in/load out including, but not limited to: The safe operation of equipment and tools. No smoking within twenty five (25) feet of any exterior doors and only in designated smoking areas. No drinking of alcoholic beverages or use of illegal substances on OCC property or parking lots. Tailgating is prohibited. No refueling, de-fueling, storage of gasoline, kerosene, LPG or other fuels and liquids. Hallways, doors and fire lanes may not be blocked with freight, equipment, display material, etc. at any time. Crate/pallet storage is not permitted inside or outside building areas under any circumstances. Children under the age of 18 are not permitted in the Exhibit Halls or on the loading dock during load in/load out hours. Children must be supervised at all times by an adult.

#### LOAD IN / LOAD OUT

In order to protect building finishes, no loading or unloading is permitted through public entrance areas (i.e. North or South Lobby, East Drive, pre-function areas, etc.). With prior authorization from your Event Manager, limited loading and unloading of hand-carried items may be permitted when no other events are in house. Load In/Load Out Lighting is set at thirty three percent (33%). "Work lights" will be provided at no charge in Exhibit Halls during load in and load out. One hundred percent (100%) "show lights" will be provided thirty (30) minutes prior to show opening and meetings. Lighting requests outside these parameters will be charged at the prevailing hourly rate. Air conditioning and/or heat are not provided on load in or load out days. Air conditioning or heat may be requested during these periods, but will only be provided when the exterior doors are closed and hourly charges will apply. Air conditioning and/or heat are provided complimentary during show hours at energy compliant settings in the active rooms. The Exhibit Hall loading doors must be closed one hour prior to start of show in order to provide appropriate heating and cooling levels.

#### LOBBY AREAS ARE FOR COMMON USE / UNLESS CONTRACTED

Lobby areas are considered public space and are reserved for uses such as registration, circulation, information, food service, etc. and use for these purposes is subject to approval by the OCC. Registration tables, equipment, telephones, Internet and electrical services are not included but are available for an additional charge. No motorized vehicles, forklifts, gas or electric carts may be used in public areas without prior permission from the OCC.

#### LOST AND FOUND

Lost and found items will be held in the Security Office at the OCC for up to thirty (30) days. Claimed items will be returned upon verification of the owner; however, the OCC will not be responsible for the cost associated with mailing or shipping lost and found items. Items are discarded after thirty (30) days. See Abandonment of Goods section.

#### **MEETING SPECIFICATIONS**

Initial meeting specifications should be provided to the Event Manager a minimum of sixty (60) days prior to the event in order to secure our lowest rates. Orders placed seven (7) days or less in advance of move in date are subject to premium rates.

#### **OFFICE EQUIPMENT**

Rental of computers, fax machines, copiers, etc. is available at OCC. Please contact your Event Manager for pricing.

#### **PARKING**

The OCC can easily accommodate over 1336 parking spaces. Parking is charged per entry with no in and out privileges. Parking in fire lanes, loading dock areas or any other location posted as "No Parking" is not permitted. Unauthorized vehicles will be removed at owner's expense. Overnight parking of all private vehicles, including RVs in the OCC parking lots is prohibited by City Ordinance and will be towed at owner's expense. Tradeshow Contractors should make arrangements with the Event Manager for parking of trucks/trailers. All personnel should park in the OCC designated parking areas. Current parking rates apply to all vehicles.

#### POWER CABLES AND LINES

Power cables and lines may not block ingress/egress and/or any emergency exit doorways. ALL power cables

must be flown up and over emergency exits. For additional details on this Fire Code, please contact the Event Manager. Cable ramps/yellow jackets are only permitted in backstage areas with prior approval. Please make arrangements with the Event Manager sixty (60) days in advance of arrival.

#### RECYCLING

Recycling is part of the OCC's operating philosophy. The OCC recycles paper, cardboard, plastic, cans, bottles, wood pallets and more. Recycle containers are made available throughout the facility and should be used whenever possible.

#### REMOVAL OF PROPERTY

In the event that the premises are not vacated upon expiration of the contract term, the OCC will remove, at your expense, all remaining goods, wares, merchandise, equipment and property of any kind. The OCC shall not be liable for any damages to or loss of such goods, wares, merchandise or property which may be sustained by reason of such removal. Overtime fees will apply for venue and labor. Licensee and its contractors are responsible for the removal and disposal of all tape, trash, crates, pallets, packing material, etc. prior, during and upon completion of use, at Licensee's expense. Items are to be placed in the appropriate refuse or recycling bins located in the loading dock area.

#### **RIGGING**

Rigging plots must be submitted to your Event Manager sixty (60) days prior to event date. Projection Presentation Technology is OCC's exclusive rigging provider. Projection's rigging supervisor will determine rig call and crew, based upon client needs. Banners and/or signage that weigh less than 10 lbs. and do not require a motor to hang can be hung from the floating grid in the Exhibit Hall pre-function area. Contact your Event Manager for pricing. Banners and/or signage can only be hung on fabric panels with wall hooks. Painters tape is the only permitted tape for the walls.

#### **ROOM SET CAPACITIES**

Room capacities vary with the addition of staging, dance floors or audio visual equipment. Please check with your Event Manager to confirm room capacities prior to preparing room specifications for your event. Any changes to another seating style after the initial sets have been completed will be charged at \$250.00 plus labor. If the change in a meeting room set is to a Food and Beverage function set, there will be no charge. To convert a Food and Beverage function set that was initially a meeting room set back to a meeting room set will be charged at \$250.00 plus labor. If additional equipment is required above that which is included in the daily rental, your assigned Event Manager will order that equipment at the prevailing rates detailed on the "Current Schedule of Rates" and billed on the final invoice. Please reference Floor Plans.

#### **SECURITY**

#### Facility Security

Our professional personnel maintain 24-hour security coverage for the facility, monitor Fire Life Safety Systems and are responsible for securing all interior and exterior doors.

#### **Event Security**

The OCC management and Ontario Police Department may determine what security will be required for each event. Security is scheduled at a minimum of one half hour prior to doors opening and one half hour after closing to the public. Four (4) hour minimums, or more, are required. Security that is not provided by OCC must have a valid City of Ontario Business License and be approved by the OCC Management and the Ontario Police Department prior to doing business in the facility. Armed guards are exclusive and contracted through OCC. Ontario Police Department reserves the right to require police officers as deemed necessary. Additional staffing for badge checkers, overnight security, etc. is at Licensee's discretion and expense. Please place a request for security or additional staffing services through your Event Manager a minimum of thirty (30) days prior to the event start date. Security personnel must be scheduled one half hour prior and one half hour after actual times in order to provide the proper level of service. See No Surprise List

#### **SERVICE ANIMALS**

Only properly identified service animals are permitted on the OCC premises. No pets allowed.

#### SHIPPING/STORAGE

All freight should be handled through your decorator. In the event you are not using a decorator, contact your Event Manager to arrange early shipments. Storage fees will be applied to your settlement invoice. Freight being delivered in advanced without notice will not be accepted.

#### SIGNAGE

The OCC permanent graphics, signs or displays may not be visibly blocked in any manner, nor may temporary signs or decorations be attached to permanent building graphics.

#### **SMOKING / NON-SMOKING POLICY**

The OCC is a non-smoking facility. Smoking is not permitted within the facility or within twenty five (25) feet of any exterior entrance door. This policy applies to any vapor type cigarettes. Smoking is allowed only in designated smoking areas.

#### SOLICITING

No soliciting is permitted on the OCC premises, which includes any portion of the OCC building, parking areas and walkways.

#### **TAILGATING**

No tailgating is permitted.

#### **VENDORS**

Each vendor must have a valid California Seller's Permit. Contact the State Board of Equalization at 949-223-5447 for compliance and CA sales tax regulation information. Each promoter/show manager must contact the City of Ontario Business Licensing at 909-395-2022 regarding the Itinerant Vendor/Event Permit.

#### WALLS / AIRWALLS

Movement of air walls and/or equipment may only be performed by OCC personnel. Walls and doors must be protected from damage at all times. Items may not be attached to or lean against walls or doors, nor used to hold or prop doors open.
