1. AUTOMATIC EXTENSION OF PRIVILEGES DURING A DISASTER

- There are circumstances, such as during a disaster, under which The Joint Commission (TJC) permits an automatic extension of medical staff reappointment time frames.
- TJC allows an automatic extension of medical staff reappointment beyond the two-year period, provided the following conditions are met:
 - A National emergency has officially been declared.
 - The established Practitioners' privileges are scheduled to expire during the time of the declared National emergency.
 - Extending the duration of Practitioners' privileges during an emergency is not otherwise prohibited by state law.
- A National emergency for conditions caused by a novel coronavirus, COVID-19, was declared on March 13, 2020
- ARMC activated the Hospital Incident Command System on March 16, 2020
- These conditions are all met relevant to the Practitioners listed in Sections No. 2 and 3 below.

2. APPLICATIONS FOR REAPPOINTMENT - MEDICAL STAFF

The privileges of the Practitioners listed in item No. 2 are scheduled to expire during the time of the declared National emergency. The Practitioners listed have completed and clean application for reappointment, and have not had any disciplinary actions against them by a licensing entity within the past two years. The recommendations for reappointment have been reviewed and approved by the Department Chair, Credentials Committee, and Medical Executive Committee.
