IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 2

It is hereby agreed to amend Contract No. 20-969, effective April 1, 2022, as follows:

SECTION V. FISCAL PROVISIONS

Paragraphs A is amended to read as follows:

A. The maximum amount of reimbursement under this Contract shall not exceed \$1,364,855, and shall be subject to availability of funds to the County.
