AMENDMENT NO. 2

It is hereby agreed to amend Contract No. 18-96, effective August 16, 2020, as follows:

VIII TERM

Section VIII is amended to read as follows:

This Contract is effective as of February 14, 2018 and is amended from its original expiration date of August 15, 2020, to expire on August 15, 2021, but may be terminated earlier in accordance with provisions of Section IX of the Contract. The contract term may be extended for one (1) additional one-year period by mutual agreement of the parties.

XI. CONCLUSION

Section XI. CONCLUSION, Paragraph C is amended to read as follows:

- C. This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the

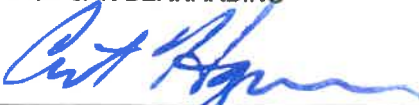
party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.

Section XI. CONCLUSION is amended to add Paragraph D as follows:

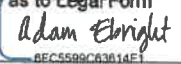
