IT IS HEREBY AGREED AS FOLLOWS:

The City of Adelanto (CITY) and the San Bernardino County Fire Protection District (SBCFPD) agree to amend Agreement No. 18-397 (Agreement) as follows:

Pursuant to Section 3.B. of Agreement, Section 3.A. is amended to read as follows:

1. Section 3.A. is amended to read as follows:
 3. Compensation
 - A. For services provided by SBCFPD to CITY on and after July 1, 2026, CITY shall pay SBCFPD the total lump sum of \$7,305,909 annually, subject to future annual adjustments as described in Section 3.B. CITY shall pay SBCFPD on a monthly basis, in accordance with the payment schedule set below. A cost breakdown of the lump sum annual amount for SBCFPD Fiscal Year 2026-27 is shown in Exhibit "A", attached hereto and incorporated herein by this reference. Payments shall be due by the first (1st) day of each month of service pursuant to Health and Safety Code section 13878. SBCFPD shall have the right to terminate this Agreement sooner than provided for in Section 20 if the CITY does not make timely payments of its obligations hereunder to SBCFPD.
