RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING AS THE GOVERNING BODY OF COUNTY SERVICE AREA 70, ZONE R-15A (LANDERS CAMPSITE), CERTIFYING ELECTION RESULTS FOR PROPOSED PROPERTY RELATED SERVICE CHARGE FOR ROAD GRADING, OPERATIONS, AND MAINTENANCE SERVICES

On Tuesday, June 10, 2025, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, on this date, at the time of the public hearing in the matter of the formation certain prescribed land (the "Subject Zone"), this Board of Supervisors (this "this Board") of San Bernardino County, acting in its capacity as governing body of County Service Area 70, conducted a public hearing, and at the close of the public hearing, this Board determined that a majority protest under Section 25217.1 of the Government Code and Proposition 218 was not made at the hearing, and

WHEREAS, at the conclusion of the public hearing, this Board adopted its Resolution authorizing and calling for a special mailed-ballot election pursuant to Proposition 218, and

WHERAS, a Certificate of Clerk regarding Receipt of Property Owner Waiver and Consent Form, and Ballot and Declaring Election Results, dated this same date (the "Clerk's Certificate") executed by the Clerk of the Board (the "Clerk"), has been filed with this Board, certifying that a completed ballot has been returned to the Clerk for the sole landowner-voter eligible to cast a ballot in said mailed-ballot election, with all votes cast as "Yes" votes in favor of the ballot measure, and further certifying on said basis that the special mailed-ballot election was closed, and

WHEREAS, this Board has received, reviewed and hereby accepts the Clerk's Certificate and wishes by this resolution to declare the results of the mailed-ballot election;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

- 1. This Board finds and determines that the foregoing recitals are true and correct.
- 2. This Board finds and determines and declares that the ballot measure submitted to the qualified elector of County Service Area 70, Zone R-15A has been passed and approved by that qualified elector in accordance with the Cal. Const. Art. XIII D, § 6 and Proposition 218 and made subject to the property related service charge.
