**AMENDMENT No. 02
CONTRACT No. 25-255**

Department of Behavioral Health Comprehensive Treatment Campus

The following are amendments to Contract No. 25-255 with Snyder Langston, LLC for the Department of Behavioral Health Comprehensive Treatment Campus ("Project").

WHEREAS, a construction contract ("Agreement") was entered into between the San Bernardino County ("County"), and Snyder Langston, LLC ("Contractor"), on April 29, 2025 to perform certain work as described in the Project Bid Documents for construction of the Project;

WHEREAS, a portion of the work for the Project is funded by a Community Care Expansion grant from the State of California and managed by HORNE LLP;

WHEREAS, HORNE LLP has notified the County that it will operate under a new entity name, BDO Government Services, LLC (BDO GS), which will be the new third-party administrator under the Community Care Expansion Program; and

WHEREAS, the construction contract with Snyder Langston, LLC must be amended to reflect the name change of HORNE LLP to BDO Government Services, LLC.

NOW THEREFORE, the Agreement is hereby amended as follows:

1. All references to HORNE LLP contained in Contract No. 25-255 and its supporting and incorporated documents are hereby amended to reflect the name change to BDO Government Services, LLC. This includes, but is not limited to the insurance provisions of Paragraph 11.2.1.1 of the General Conditions, the indemnification provisions of Paragraph 3.18.1 of the General Conditions, and the bonding provisions of Paragraph 11.1.1.1 of the General Conditions.
2. REPLACE EXHIBIT C – Payment Bond, included with this Amendment.
3. REPLACE EXHIBIT D – Performance Bond, included with this Amendment.
4. REPLACE EXHIBIT N – Community Care Expansion Program Funding Agreement, included with this Amendment.

All other terms and conditions of the Agreement, and approved change orders, shall remain unchanged.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
