RESOLUTION NO. 2024-150

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY TO ESTABLISH A NO PARKING ZONE ON CAJON COURT, DEVORE AREA

On October 8, 2024, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Department of Public Works completed a traffic engineering investigation on Cajon Court (200050) in the Devore area; and,

WHEREAS, the Board of Supervisors is authorized to establish parking restrictions on County roads; and,

WHEREAS, the Board of Supervisors desires to establish a parking restriction on Cajon Court in the Devore area.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

- 1) Due to conditions affecting the health and safety of the public and the California Department of Forestry and Fire Protection (CalFire) Devore Fire Station utilizing Cajon Court (200050), in the Devore area, the Board of Supervisors, pursuant to an engineering and traffic investigation, finds and hereby deems it necessary to:
 - Establish a "No Parking/Tow-Away Zone", pursuant to County Code § 52.0132(a), on south side of Cajon Court (200050) from Cajon Boulevard northwesterly for 450 feet in the Devore area;
 - b. Establish a "No Parking/Tow-Away Zone", pursuant to County Code § 52.0132(a), on north side of Cajon Court (200050) from 300 feet northwest of Cajon Boulevard westerly for 60 feet in the Devore area; and
 - c. Establish a "No Overnight Parking/Tow-Away Zone", pursuant to County Code §§ 52.018(a) and 52.0132(a), on north side of Cajon Court (200050) from 240 feet northwest of Cajon Boulevard westerly for 200 feet in the Devore area.
- 2) The County Road Commissioner is hereby directed to perform such acts as are necessary to establish the parking restrictions above and implement the terms of this resolution.
