

**AMENDMENT NO. 1 TO
AGE WISE TECHNICAL ASSISTANCE AGREEMENT**

**Contract No. 24-301-A1
between Korean Community Services, Inc. ("KCS" or "Grantee") and San Bernardino County
("Contractor")**

RECITALS

WHEREAS, KCS and Contractor entered into an Agreement on May 1, 2024 to provide technical assistance services for the Age Wise Program funded by the Behavioral Health Services Oversight and Accountability Commission (BHSOAC), formerly known as Mental Health Services Oversight and Accountability Commission (MHSOAC). This agreement is amended as follows:

ENTIRE AGREEMENT

All references to "Mental Health Services Oversight and Accountability Commission (MHSOAC)" in the Contract is hereby amended to read "Behavioral Health Services Oversight and Accountability Commission (BHSOAC)."

SECTION-PAYMENT PROVISIONS

Amend Payment Provisions to read as follows:

KCS shall pay Contractor ten (10) percent of the Age Wise grant award, \$1,797,529.00, from Behavioral Mental Health Services Oversight and Accountability Commission (BHSOAC) to provide technical assistance services to KCS, which is a maximum of \$179,752.90. Payment terms are outlined in Exhibit A. Contractor shall submit such invoice periodically or at the completion of services, but in any event, not later than thirty (30) days after completion of services. The invoice shall set forth the amounts claimed by Contractor for the previous period, together with an itemized basis for the amounts claimed, and such other information pertinent to the invoice

EXHIBIT A- SCOPE OF WORK
