IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT No. 9

Contract No 18-640, for the Sheriff/Coroner/Public Administrator to provide law enforcement services to the Redlands Unified School District (RUSD), in the form of a Deputy Sheriff, serving as a School Resource Officer is hereby amended, effective October 4, 2025 as follows:

- (1) By deleting the Schedule A, referred to in Sections I.A. and II.A of the contract, in its entirety, and replacing it with the Schedule A that is attached hereto and incorporated herein by this reference.
- (2) To add Section VIII – Prohibition on Contracting with Entities that Require Certain Internal Confidentiality Agreements or Statements-Representation (FAR 52.203-18).

VIII – Prohibition on Contracting with Entities that Require Certain Internal Confidentiality Agreements or Statements-Representation (FAR 52.203-18).

In compliance with Federal Acquisition Regulation 52.203-18, RUSD shall not require employees or subcontractors of RUSD seeking to report waste, fraud, or abuse, to sign internal confidentiality agreements or statement prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information. To the extent RUSD has required employees or subcontractors to sign internal confidentiality agreements or statements in the past, RUSD shall notify current employees and subcontractors that those prohibitions and restrictions are no longer in effect. RUSD shall include this clause in all subcontracts.

(3) To add Section IX – Service Contract Labor Standards (FAR 52.222-52, 52.222-53, 22.1003-4).

IX – Service Contract Labor Standards (FAR 52.222-52, 52.222-53, 22.1003-4)

To the extent applicable, RUSD agrees to comply with and to provide any information necessary for the County to comply with Federal Acquisition Regulations 52.222-52, 52.222-53, and 22.1003-4.

Except as amended, all other terms and conditions of the contract remain as stated therein.
