IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 2

It is hereby agreed to amend Contract No. 23-524, as follows:

SECTION V. FISCAL PROVISIONS

Section V. FISCAL PROVISIONS, Paragraph A, D, and E are amended to read as follows:

- A. The maximum amount of payment under this Contract shall not exceed \$1,370,000, of which approximately \$1,100,000 is federally funded through the Administration for Children and Families, and approximately \$270,000 is funded by the Mental Health Services Act, and all funding shall be subject to availability of other funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.
- D. All service documentation shall be completed and submitted in ChildPlus no later than the fifth (5th) day of the month following the month in which services were rendered. All invoices shall be submitted to the Preschool Services Department (PSD) no later than the fifteen (15th) day of the month following the month in which services were provided.
- E. Invoices shall be issued with a net sixty (60) day payment term with corresponding SAP Contract and/or Purchase Order number stated on the invoice. Invoices shall be submitted to psdaccountspayable@psd.sbcounty.gov.

All other terms and conditions of Contract No. 23-524 remain in full force and effect.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF, or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
