IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO.8

It is hereby agreed to amend Contract No. 07-950 as follows:

Section V, Paragraph A is amended to read:

- A. The maximum amount of payment under this Contract shall not exceed \$866,717.40 and shall be subject to availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem. The maximum is a total dollar amount; it includes the original contract amount and all subsequent amendments, and is broken down as follows:

All other terms and conditions of Contract No. 07-950 remains in full force and effect.
