THIS MEMORANDUM OF LEASE AND LANDFILL GAS SALE AND PURCHASE AGREEMENT (this "Memorandum"), dated as of the _____ day of _____, 2022, is by and between SAN BERNARDINO COUNTY DEPARTMENT OF PUBLIC WORKS, SOLID WASTE MANAGEMENT DIVISION, CALIFORNIA, a body corporate and politic ("Lessor"), and BIOFUELS SAN BERNARDINO BIOGAS, LLC, a Delaware limited liability company ("Lessee").

WHEREAS, Lessor and Lessee have entered into (a) an Amended and Restated Site Lease dated as of June 28, 2022 (together with all related Exhibits and Schedules, the "**Lease**"), under which Lessor leases to Lessee, and Lessee leases from Lessor the "**Project Site**", as more particularly described on Exhibit A attached hereto and incorporated herein by reference, which is a portion of the real property located at 2390 Alder Avenue, Rialto, California (the "**Landfill**"); and (b) an Amended and Restated Landfill Gas Sale and Purchase Agreement dated as of June 28, 2022 (together with all related Exhibits and Schedules, the "**LFG Agreement**" and together with the Lease, the "**Agreements**"), under which Lessor grants, conveys, transfers, and assigns, the rights, title, and interest in and to Landfill Gas generated from the Landfill existing or to exist during the Term to the extent more fully described in the Agreements, including, but not limited to, all economic benefits and Environmental Attributes thereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Defined Terms. Capitalized terms used but not defined herein shall have the meaning given in the LFG Agreement.
2. Name and Principal Place of Business of Lessor. The name and address of Lessor is SAN BERNARDINO COUNTY DEPARTMENT OF PUBLIC WORKS, SOLID WASTE MANAGEMENT DIVISION, CALIFORNIA, with its principal place of business at 222 W. Hospitality Lane, Second Floor, San Bernardino, California 92415.
3. Name and Principal Place of Business of Lessee. The name and address of Lessee is BIOFUELS SAN BERNARDINO BIOGAS, LLC, a Delaware limited liability company, with its principal place of business at 4444 Westheimer Road, Suite 450G, Houston, Texas 77027.

4. Term. The initial term of the Lease and LFG Agreement commenced on September 24, 2019 and expires no later than September 24, 2023 (the “Option and Construction Term”). At the conclusion of the Option and Construction Term (as set forth in more detail in the Lease and LFGA), the term shall automatically convert to twenty (20) years.

This Memorandum is subject to the Agreements and any amendments, modifications, alterations, renewals, and extensions of the Agreements. The terms and provisions of the Agreements are incorporated in this Memorandum by reference. In the event of any conflict between this Memorandum and the Agreements, the provisions of the Agreements shall control.
7. Counterparts. This Memorandum may be executed in multiple counterparts, each of which shall be deemed an original and all of which when taken together shall constitute one and the same document.
8. Governing Law. This Memorandum shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to the conflict of laws principles thereof.

Legal Description of Project Site

Thence South $89^{\circ}37'51''$ West along the North line of said Southeast $\frac{1}{4}$ a distance of 1802.50 feet to a point;

Thence South $00^{\circ}22'09''$ East a distance of 129.60 feet to a point on a line that is parallel with and 129.60 feet southerly, measured at right angles, from the North line of said Southeast $\frac{1}{4}$, said point being the True Point of Beginning;
