



**PRODUCT PRICING AGREEMENT**

This **Product Pricing Agreement**, consisting of this cover page, the attached Standard Terms and Conditions, and any applicable schedules checked below (collectively, this “**Agreement**”), is entered into by and between Stryker Sales, LLC., acting through its Neurovascular Division, (“**Stryker**”) and San Bernardino County on behalf of Arrowhead Regional Medical Center (“**Institution**”), Account Number 210008 and, if applicable, the acute health care facilities listed on Schedules (B,C) (each individually referred to as a “**Participant**,” and collectively with Institution, as the “**Customer**”). Stryker and Customer are individually referred to herein as a “**Party**” and collectively as the “**Parties**.”

**Overview and Background:** Stryker manufactures and sells certain medical device and/or Neurovascular products. For purposes of this Agreement, the term “**Participant**” means an entity in which Institution owns or controls, directly or indirectly, at least fifty percent (50%), and provides management services for such entity and has the authority to bind the entity to obligations hereunder. Institution wishes to purchase Products (as defined herein) on behalf of itself and Participants, at the prices and subject to the terms, conditions and assurances set forth in this Agreement.

**Effective Date and Term:** This Agreement, including all pricing set forth herein, shall commence on the first day of the month following the date of last signature (the “**Effective Date**”), and shall continue through and expire twenty-four (24) months thereafter, unless earlier terminated pursuant to the terms of this Agreement.



Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.

2. Products; Prices for Products. Only Products expressly covered by Schedules (B, C, and H) and purchased under this Agreement are eligible for the pricing offered under this Agreement. Customer understands that Product pricing and any other incentive offered under this Agreement is contingent upon Customer's, or, if applicable, a Participant's compliance with all material terms and conditions set forth in this Agreement including, but not limited to, those conditions set forth in Schedules (B, C) the requirement to pay outstanding invoices and provide purchase orders as set forth in the section entitled "Purchase Orders; Invoices; Payments."
3. Purchase Orders; Invoices; Payments. Customer and any Participant that purchase Products directly from Stryker will order Products by fax, phone, email, or Electronic Data Interchange ("EDI"), and must submit purchase order number to Stryker with the order. Upon shipment of Products to Customer or any Participant, Stryker will submit to Customer or the Participant, as the case may be, an invoice for such Products, and Customer or the Participant, must pay in full all invoices within thirty (30) days from the date of invoice. If Customer or a Participant wishes to dispute an invoice or portion thereof, Customer or such Participant must notify Stryker in writing within thirty (30) days of its receipt. The writing must provide sufficient detail regarding the basis and amount of the dispute. If neither Customer nor Participant disputes an invoice within thirty (30) days of its receipt of same, the invoice will be deemed to have been approved by Customer or the Participant.
4. Product-Related Services. Stryker will provide technical training, including initial training for new users and supplemental training for existing users, as needed to promote the safe and effective use of the Products. Such technical training shall be provided to any health care practitioner who uses or intends to use the Product and is employed by, or is on the active medical staff of, Customer or any purchasing Participant. If Stryker provides technical training to a health care practitioner, Stryker may pay for or reimburse reasonable expenses, including meals, lodging and transportation, actually incurred by such health care practitioner in connection with the technical training. Notwithstanding the foregoing, Stryker will not reimburse Customer, Participants or any third party for other fees or surcharges charged by Customer, Participants or a third party in connection with this Agreement; including, but not limited to, surgical scrubs, inventory lockers, supply chain management services, web-based product catalog services or sterilization trays.
5. Shipping; Delivery. Except as otherwise provided in this Agreement, all Products purchased directly from Stryker are shipped F.O.B. Destination-Origin, freight and insurance is prepaid and added to the invoice. Stryker shall assist Customer with any issues related to shipping. Products purchased directly from Stryker will be shipped using Customer's approved third-party carrier (FedEx) account number- 7176961482. For Products purchased on a consignment basis, the shipping terms are outlined in Section 3.a of the Consignment Agreement dated August 26, 2019, unless terminated. The terms of the active Consignment Agreement will apply to the shipping of consignment products.
6. Reporting. Stryker, as supplier, hereby informs Customer, as buyer on behalf of itself and each purchasing Participant, of each Participant's obligation to make required reports (including reporting on net prices paid for items supplied hereunder) under the Federal Medicare and Medicaid Anti-Kickback Statute and the regulations thereunder (42 CFR Part 1001.952(h)). Pricing under this Agreement may constitute discounts on the purchase of Products. Institution represents that (i) it shall make on behalf of each Participant or cause each Participant to make on its own behalf, all required cost reports, and (ii) it has the power and authority to make or cause such cost reports to be made. Stryker shall provide to Customer any and all information reasonably requested relating to any discounts under this Agreement to enable Customer to comply with its reporting requirements.
7. WARRANTY. ANY WARRANTIES PROVIDED BY STRYKER WITH RESPECT TO A GIVEN PRODUCT ARE AS DESCRIBED IN THE LABELING ACCOMPANYING UNITS OF THAT PRODUCT ON PURCHASE. STRYKER HEREBY EXPRESSLY DISCLAIMS ANY AND ALL EXPRESS OR IMPLIED WARRANTIES REGARDING THE PRODUCTS INCLUDING, BUT NOT LIMITED TO, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
8. LIMITATION OF LIABILITY. IN NO INSTANCE WILL EITHER PARTY BE LIABLE TO THE OTHER PARTY OR ANY PARTICIPANT FOR INCIDENTAL, PUNITIVE, SPECIAL, COVER, EXEMPLARY, MULTIPLIED OR CONSEQUENTIAL DAMAGES OR ATTORNEYS' FEES OR COSTS FOR ANY ACTIONS UNDER OR RELATED TO THIS AGREEMENT, EXCEPT AS TO ANY SUCH DAMAGES THAT RECOVERABLE AS AN INDEMNIFICATION OBLIGATION IN THIS AGREEMENT.
9. Indemnity. Stryker will defend and indemnify Customer and Participants from any third-party liability and/or damages which Customer or Participants suffer directly as a result of a defect in workmanship or design of the Products or any negligence or intentional misconduct of Stryker, its agents, or employees. This indemnification applies only if the instructions outlined in the Product's labeling, manual, and/or instructions for use are followed. This indemnification does not apply to liability and/or damages arising from: (i) an injury due to the negligence of any person other than an employee or agent of Stryker; (ii) the failure of any person other than an employee or agent of Stryker to follow any instructions for use of the Product; or (iii) the use of any product not purchased from Stryker, or Product that has been modified, altered, reprocessed, or repaired by any person other than an employee or agent of Stryker. Indemnification shall not apply against any claims or losses or injuries arising from (i), (ii), or (iii) above resulting from the sole negligence or willful misconduct of any employee or agent of Customer or a Participant.

Intellectual Property. Stryker also agrees to indemnify and defend Customer from any third party claims against Customer alleging that Customer's use of the Products in accordance with the Products' labeling, manuals, and/or instructions for use, constitutes an infringement, misappropriation or other violation of any U.S. patent, trademark, copyright, trade secret or other intellectual property right. Should a Product become, or in Stryker's opinion is likely to become, the subject of a claim of any such infringement, Stryker may, in its sole discretion, either procure for Customer the right to continue using the Product, or replace it or modify it to make it non-infringing without incurring a material diminution in performance or function. If the foregoing options are not available on commercially reasonable terms, Stryker may refund the purchase price for the Product pro-rated for depreciation based on a three-year straight-line model. The foregoing indemnification does not apply to any claims arising from: (i) the combination of any Stryker Product with one or more non-Stryker products wherein such combination is the sole basis of the claim; (ii) the use of the Products contrary to their labeling, manuals, and/or instructions for use, or (iii) modification of any Product by any person other than Stryker without Stryker's express written authorization. Stryker will have no liability hereunder unless it is notified promptly of any such claim and given control of the defense and any settlement thereof. However, Customer's failure to provide or delay in providing such notice will relieve Stryker of its obligations only if and to the extent that such delay or failure materially prejudices Stryker's ability to defend such lawsuit or claim.

10. Insurance.

a. During the Term of this Agreement, Stryker will comply with the insurance requirements set forth on Schedule F.

b. During the Term of this Agreement, Customer shall maintain commercial general liability insurance with limits of \$1,000,000 per occurrence and \$3,000,000 annual aggregate; automobile liability insurance with a combined single limit of \$1,000,000 each accident covering Customer's use of owned, non-owned and hired vehicles; and workers compensation insurance subject to statutory limits and employer's liability insurance with limits of \$1,000,000 per accident, and \$1,000,000 per employee and policy limit for disease covering claims arising out of Customer's activities and obligations under this Agreement. Customer may comply with these insurance requirements through a program of self-insurance. Upon request by Stryker, Customer will provide an insurance certificate issued by an authorized agent of the insurer(s) or a certificate of self-insurance evidencing the above referenced insurance such coverage.

11. Termination, Effect. Unless otherwise stated herein, either Party may terminate this Agreement at any time, without cause, by giving thirty (30) days' advance written notice to the other Party. Notwithstanding the foregoing, if either Party terminates this Agreement without cause, the terminating Party shall pay the non-terminating Party an amount equal to ten percent (10%) of Customer's and the Participants' total Product purchases, in the aggregate, for the twelve (12) month period immediately preceding such early termination. The Parties agree that the ten percent (10%) payment represents a reasonable estimate of the diminution in value to the non-terminating Party and does not constitute a penalty. All accrued rights or responsibilities will survive termination or expiration of this Agreement. Upon termination or expiration of this Agreement, the terminating party shall, within sixty (60) days upon issuance of an invoice, pay the non-terminating party all amounts owed pursuant to this Agreement. The ARMC Chief Executive Officer is authorized to terminate this Agreement on behalf of Customer.

Either party may terminate this Agreement with cause upon a material breach of the Agreement by the other party. Such termination may be effectuated upon written notice by the non-breaching party to the breaching party.

12. Confidentiality. Stryker, Customer and each Participant: (a) shall hold in confidence this Agreement and the terms and conditions contained herein (including, without limitation all terms relating to Product pricing) and any information and materials which the disclosing party designates as proprietary or confidential to the extent such information and materials are protected by law; and (b) hereby covenant that they shall not disclose such information to any third party without prior written authorization of the one to whom such information relates, except and to the extent disclosure is required by law. The rights and remedies available to a party hereunder shall not limit or preclude any other available equitable or legal remedies. Notwithstanding anything in the foregoing, Stryker understands that Customer is a public entity subject to, among other laws, decisions, rules and statutes, the Ralph M. Brown Act, the California Public Records Act, and the Sunshine Ordinance in its County Code and Stryker understands that this Agreement may be made public as part of the approval process required under California law and that no further consent or notice to Stryker is required for such disclosure.

13. Debarment and Suspension. Stryker hereby represents that to its knowledge, it is not convicted of any criminal offense related to health care nor is it currently debarred, excluded, or otherwise ineligible for participation in any federal or state government health care program, including Medicare and Medicaid. Further, Stryker represents that to its knowledge, no proceedings or investigations are currently pending or to Stryker's knowledge threatened by any federal or state agency seeking to exclude Stryker from such programs or to sanction Stryker for any violation of any rule or regulation of such programs.

14. Legality and Severability. The parties' actions under the Agreement shall comply with all applicable laws, rules, regulations, court orders and governmental agency orders. The provisions of this Agreement are specifically made severable. If a provision of the Agreement is terminated or held to be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall remain in full effect.

15. Levine Act - Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439). Stryker has disclosed to the Customer using Schedule G – Levine Act - Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439), whether it has made any campaign contributions of more than \$500 to any member of the San Bernardino County ("County") Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney] within the 12 months before the date this Agreement was approved by the Board of Supervisors. Stryker acknowledges that under Government Code section 84308, Stryker is prohibited from making campaign contributions of more than \$500 to any member of the Board of Supervisors or other County elected officer for 12 months after the County's consideration of the Agreement.

In the event of a proposed amendment to this Agreement, Stryker will provide the County a written statement disclosing any campaign contribution(s) of more than \$500 to any member of the Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed amendment.

Campaign contributions include those made by any agent/person/entity on behalf of the Stryker or by a parent, subsidiary or otherwise related business entity of Stryker.

16. If applicable, Stryker will disclose to the Customer using Schedule G - Campaign Contribution Disclosure Senate Bill 1439, whether it has made any campaign contributions of more than \$250 to any member of the San Bernardino County ("County") Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney] within the 12 months before the date this Agreement was approved by the Board of Supervisors. Stryker acknowledges that under Government Code section 84308, Stryker is prohibited from making campaign contributions of more than \$250 to any member of the Board of Supervisors or other County elected officer for 12 months after the County's consideration of the Agreement.

In the event of a proposed amendment to this Agreement, Stryker will, upon request, provide the County a written statement disclosing any campaign contribution(s) of more than \$250 to any member of the Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed amendment.

Campaign contributions include those made by any agent/person/entity on behalf of Stryker or by a parent, subsidiary or otherwise related business entity of Stryker.

Miscellaneous.

- a. No Party shall be liable for failure or delay in performing obligations set forth in this Agreement, and no Party shall be deemed in breach of its obligations, if such failure or delay is due to natural disasters or any causes reasonably beyond the control of such Party.
- b. This Agreement shall be governed by and construed in accordance with the laws of the State of California. Any action arising under this Agreement shall be venued in the state or federal courts of California.
- c. This Agreement shall inure to the benefit of, and be binding upon, Customer, each Participant and Stryker and their respective successors and assigns. Customer represents to Stryker that it is duly authorized to execute this Agreement, and that it has authority to legally bind the Participants to the terms of this Agreement. Neither Party may assign any of its rights or obligations under this Agreement, without the prior written consent of the other Party. Any purported assignment in violation of the preceding sentence will be void.
- d. Any notice required under this Agreement shall be in writing, either by electronic mail or registered mail, in which case, postage will be prepaid and addressed to the Parties at their respective addresses as first set forth above.
- e. This Agreement constitutes the entire agreement between the Parties and, as of the Effective Date, supersedes all prior negotiations and replaces any existing agreement between the Parties for purchases of products and services comparable to the Products and/or services. This Agreement may only be amended by written agreement of the Parties. In the event of an inconsistency or conflict between this Agreement and any purchase order, invoice, or similar document relating to the purchase of Products, this Agreement will control.
- f. The Warranty, Liability, Indemnity, Confidentiality and Miscellaneous provisions of this Agreement shall survive its termination or expiration.



**Schedule B**

**Earned Pricing Program**

1. **Overview.** Stryker will provide a discount to Customer for the Covered Products (defined below) as set forth in Exhibit A (“Earned Pricing Program”).
2. **Covered Products; Qualifying Products; Initial Product Price; Adjustments to Product Price.**
  - a. **Covered Products.** Stryker will provide a discount for the Products set forth in Exhibit A/Schedule H (“Covered Products”). Other products which may be available from Stryker after the Effective Date of this Agreement may be added by amending this Agreement in accordance with Section 16 e. of the Agreement.
  - b. **Qualifying Products.** The discount for Covered Products is based on the purchases of (“Qualifying Products”) set forth in Exhibit B. Other products which may be available from Stryker after the Effective Date of this Agreement may be added by amending this Agreement in accordance with Section 16 e. of the Agreement.
  - c. **Initial Product Price.** Customer’s initial product pricing under this Agreement shall be the price(s) listed in Exhibit A under Initial Product Price (“Initial Product Price”). The Initial Product Price has been set based on the Customer’s agreement to purchase from Stryker during the first Purchase Period a quantity of each Covered Product that is within the range for such Covered Product set forth under the applicable tier indicated under Initial Pricing Tier on Exhibit A. A "Purchase Period" is a 180-day period during the term of this Agreement. The first Purchase Period begins on the Agreement's Effective Date and subsequent Purchase Periods run consecutively thereafter. The Initial Product Price shall be determined by Stryker and fixed for the first Purchase Period plus thirty (30) days, regardless of the number of Covered Products that are purchased during that Purchase Period.
  - d. **Adjustments to Product Price.** At the end of each Purchase Period, Stryker will calculate the number of Covered Products that Institution purchased from Stryker during such Purchase Period, net of the number of Covered Products that Institution returned to Stryker during such Purchase Period. (The total number of Covered Products purchased, net of returns, is the “Actual Products Purchased”). A Covered Product will be considered purchased on the date that Stryker ships such Product to Institution. Covered Products will be considered returned on the date that Stryker processes the Covered Products that have been returned by Institution. Based on the Actual Products Purchased during each Purchase Period, Stryker will adjust the price per Product for the next Purchase Period ("New Purchase Period ") to the appropriate tier, as indicated on Exhibits A and B.

The adjusted price for Covered Products during the New Purchase Period will become effective on the thirtieth (30th) day of the New Purchase Period and will remain in effect until the earlier of (1) the end of such Purchase Period plus thirty (30) days, or (2) expiration/termination of the Agreement.

No later than on the thirtieth (30th) day after the end of any Purchase Period, Stryker will notify Institution of the New Product price. Please indicate whether you would like to be notified via:

3. **Schedule B Effective Date:** This Schedule B, and all pricing set forth in it, becomes effective as of the signature of the last Party (the “Effective Date”) to the Agreement, which will be the first calendar day of the month after the Agreement is fully executed.
4. **Term.** This Schedule B will have a term of 24 month(s) from the Schedule B Effective Date, unless earlier terminated pursuant to the terms of the Agreement.

**Rebate**

During each period of six (6) consecutive calendar months, beginning on the Rebate Effective Date and continuing during the term of this Schedule C (each, a “Measurement Period”), Stryker will pay Institution on behalf of and for the account of the Participants, in the aggregate, a Rebate in an amount corresponding to the Eligibility Criteria as set forth below (“Eligibility Criteria”), provided Customer meets such Eligibility Criteria during the applicable Measurement Period. In the event that a force majeure event (health pandemic, natural disaster) occurs during a Measurement, the Parties will work together in good faith to determine a solution and update the applicable Eligibility Criteria on a going forward basis as needed. Stryker, in its sole discretion, reserves the right to modify the Eligibility Criteria in the event of a force majeure event (including but not limited to health pandemic, natural disaster) through a written amendment.

**REBATE EFFECTIVE DATE**

If the Agreement is fully executed by both parties on or before 4/30/2025, the Effective Date of this Schedule C shall be 4/01/2025. If the Agreement is fully executed on or after 5/01/2025 the Effective Date of the Schedule C shall be 7/01/2025 (“Rebate Effective Date”).

**TERM**

The term of this Schedule C shall be for months from the Rebate Effective Date, unless terminated earlier.

**Payment:** Provided Institution and the Participants, as applicable, comply with the material terms and conditions in this Agreement, rebates will be paid within sixty (60) days following the end of each Measurement Period as selected below. Rebates payable hereunder shall be net of (i) any Products purchased and subsequently returned and (ii) any rebates from other Stryker divisions or affiliates which Institution or the Participants may be entitled to.

**ACH Payment Institution.**

**Application of Credits.** Following the end of the Measurement Period in which a rebate credit is earned, Stryker will provide Institution on behalf and for the account of each Participant with a statement indicating the total amount of rebate credit earned by Institution and each Participant during such Measurement Period. Institution will or will cause each Participant to apply outstanding rebate credits by subtracting the appropriate amount from payments for future invoices, and will document the application of rebate credits in the remittance advice.

## SCHEDULE F Insurance Requirements

Stryker agrees to maintain insurance set forth in accordance with the requirements herein. If Stryker uses existing coverage to comply with these requirements and that coverage does not meet the specified requirements, Stryker agrees to amend, supplement or endorse the existing coverage to do so. Notwithstanding any other insurance requirements within this Agreement to the contrary, to the extent allowed by applicable law or regulation, Stryker shall be permitted to comply with these insurance requirements through a program of self-insurance.

1. Without in anyway affecting any indemnity obligations provided and in addition thereto, Stryker shall secure and maintain throughout the contract term the following types of insurance with limits as shown:
  - a. Workers' Compensation/Employer's Liability – A program of Workers' Compensation insurance or a state-approved, self-insurance program in an amount and form to meet all applicable requirements of the Labor Code of the State of California, including Employer's Liability with limits of \$250,000 per accident or each employee and policy limit for disease covering all Stryker employees.
  - b. Commercial/General Liability Insurance – Stryker shall carry Commercial General Liability Insurance covering all operations performed by or on behalf of Stryker providing coverage for bodily injury and property damage with a combined single limit of one million dollars (\$1,000,000), per occurrence and two million dollars (\$2,000,000) annual aggregate. The policy coverage shall include:
    - i. Premises operations.
    - ii. Products and completed operations liability.
    - iii. Broad form property damage (including completed operations).
    - iv. Explosion, collapse and underground hazards.
    - v. Personal injury.
    - vi. Contractual liability.
  - c. Automobile Liability Insurance – Coverage shall be written on ISO Business Auto coverage form for all owned, hired and non-owned automobiles or symbol 1 (any auto). The policy shall have a combined single limit of one million dollars (\$1,000,000) each accident for bodily injury and property damage. If Stryker is transporting one or more non-employee passengers in performance of contract services, the automobile liability policy shall have a combined single limit of two million dollars (\$2,000,000) each accident for bodily injury and property damage. If Stryker owns no autos, a non-owned auto endorsement to the General Liability policy described above is acceptable.
2. **Additional Insured.** All policies, except for Worker's Compensation, shall contain additional insured endorsements that include Customer and its officers, employees, agents and volunteers as additional insured with respect to liabilities arising out of Stryker's performance of services hereunder. Blanket endorsements are acceptable.
3. **Waiver of Subrogation Rights.** Intentionally Omitted.
4. **Policies Primary and Non-Contributory.** Except with respect to any claim or loss that arises from the negligence or willful misconduct of Customer, all policies required herein (except Workers' Compensation/ Employer's Liability) are to be primary and non-contributory with any insurance or self-insurance programs carried or administered by Customer.
5. **Severability of Interests.** Except with respect to the applicable insurance limits, Stryker agrees to ensure that coverage provided to meet these requirements is applicable separately to each insured and there will be no cross liability exclusions that preclude coverage for suits between Stryker and Customer or between Customer and any other insured or additional insured under the policy.
6. **Proof of Coverage.** Stryker shall furnish Certificates of Insurance and copies of applicable endorsements to Arrowhead Regional Medical Center evidencing the required insurance coverage at the time the Contract is executed. Stryker shall provide at least thirty (30) days written notice to Arrowhead Regional Medical Center in the event that that such required insurance is to be terminated or non-renewed, at any time between when Stryker commences performance of services hereunder and until the completion of such services. In the event that Customer has a reasonable expectation of defense and/or indemnification with respect to a third-party claim under the terms of this Agreement and Stryker or its insurer declines to accept Customer's tender of such claim, Stryker shall furnish copies of the relevant insurance policy(ies) at Customer's request.
7. **Acceptability of Insurance Carrier.** Unless otherwise approved by Risk Management, insurance shall be written by insurers authorized to do business in the State of California and with a minimum "Best" Insurance Guide rating of "A- VII".
8. **Self-Insured Retention.** Any and all self-insured retentions in excess of \$10,000 (Except with respect to Michigan self-insured workers' compensation.) shall be declared to and approved by Risk Management.
9. **Failure to Procure Coverage.** In the event that any policy of insurance required under this contract does not comply with the requirements, is not procured, or is canceled and not replaced, Customer has the right but not the obligation or duty to cancel the contract or obtain insurance if it deems necessary and any premiums paid by Customer will be promptly reimbursed by Stryker or Customer payments to Stryker will be reduced to pay for Customer purchased insurance.
10. **Insurance Review.** Insurance requirements are subject to periodic review by Customer. The Customer's Director of Risk Management or designee is authorized, but not required, to reduce, waive or suspend any insurance requirements whenever Risk Management determines that any of the required insurance is not available, is unreasonably priced, or is not needed to protect the interests of Customer. In addition, if the Department of Risk Management determines that heretofore unreasonably priced or unavailable types of insurance coverage or coverage limits become reasonably priced or available, the Director of Risk Management or designee is authorized, but not required, to change the above insurance requirements to require additional types of insurance coverage or higher coverage limits, provided that any such change is reasonable in light of past claims against Customer, inflation, or any other item reasonably related to Customer's risk. Any change requiring additional types of insurance coverage or higher coverage limits must be made by amendment to this contract. Stryker agrees to consider any such amendment within thirty (30) days of

receipt. Stryker reserves the right to cancel this Agreement at no penalty to Stryker based on any change requiring additional types of insurance coverage or higher coverage limits. Any failure, actual or alleged, on the part of Customer to monitor or enforce compliance with any of the insurance and indemnification requirements will not be deemed as a waiver of any rights on the part of Customer.

**Agent:** A third-party individual or firm who, for compensation, is representing a party or a participant in the matter submitted to the Board of Supervisors. If an agent is an employee or member of a third-party law, architectural, engineering or consulting firm, or a similar entity, both the entity and the individual are considered agents.

**Otherwise related entity:** An otherwise related entity is any for-profit organization/company which does not have a parent-subsidary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.
