IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 1

This Amendment No. 1 (Amendment) dated April 29, 2025 is made by and between Golden Star Technology, Inc. (Contractor), and San Bernardino County (County) and modifies the terms to agreement executed between the parties as of November 16, 2022 (Contract).

- 1. Delete Section F.1, in its entirety, and replace with the following:
 - **F.1** The maximum amount of payment under this Contract shall not exceed \$2,200,000. However, payment shall be made in accordance with the terms of the applicable SOW. The SOW shall set forth all costs associated with the proposed project, and, unless otherwise approved by the County, the hourly rates and costs for equipment, supplies, hardware, software, and materials. The SOW shall conform to Attachment B and G. The consideration to be paid to Contract, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.
- Add Exhibit B-1 to the Contract, as attached hereto and incorporated herein.
- 3. Levine Act Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439). Contractor has disclosed to the County using Attachment A Levine Act Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439), whether it has made any campaign contributions of more than \$500 to any

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
