

RESOLUTION NO. 2019-129

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO,
STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BODY OF COUNTY
SERVICE AREA 70, DECLARING THE INTENTION TO FORM ZONE DB-3 (MILL POND) OF
COUNTY SERVICE AREA 70**

On Tuesday, August 6, 2019, on motion of Supervisor Rutherford, duly seconded by Supervisor Rowe and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of County Service Area 70, hereby finds and determines:

(a) That this Board desires to form a new zone to be known as Zone DB-3 of County Service Area 70 pursuant to Government Code section 25217 et seq.

(b) That the exterior boundaries of the territory proposed to be formed into the said zone are described and set forth in Exhibit "A", attached hereto and incorporated herein by this reference.

(c) That Zone DB-3 is intended for the purpose of providing detention basin maintenance services.

(d) That staff is recommending that an election be conducted to determine if the property owners would be in favor approving a service charge in the amount of \$387.94 per parcel with an annual inflationary increase of up to 3% thereafter, which would provide the necessary financing for the detention basin maintenance services.

(e) That staff recommends to this Board that said Zone DB-3 (Mill Pond) of County Service Area 70 be formed if the election is successful.

SECTION 2. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of County Service Area 70, therefore, hereby resolves and orders:

(a) That this Board hereby declares the intention to form Zone DB-3 (Mill Pond) of County Service Area 70.

(b) That a public hearing shall be held at 10:00 a.m. on Tuesday, September 24, 2019, in the Chambers of the Board of Supervisors, County Government Center, 1st Floor, 385 North Arrowhead Avenue, San Bernardino, California, to consider the formation of Zone DB-3 of County Service Area 70.

(c) That the Clerk of this Board shall publish a notice of the hearing pursuant to Section 6061 of the Government Code in a newspaper of general circulation within the county, with said publication to be complete at least seven (7) days prior to the hearing date.

(d) That the Clerk of this Board shall mail notice of the hearing to all property owners within Zone DB-3 of County Service Area 70 and to each city and special district which contains, or whose sphere of influence contains Zone DB-3 of County Service Area 70 at least twenty (20) days before the hearing.

(e) That the Clerk of the Board shall post notice of the hearing in at least three (3) public places within Zone DB-3 of County Service Area 70.

(f) That at said hearing, the testimony of all interested parties for or against the formation of Zone DB-3 of County Service Area 70 will be heard.

(g) That County staff has determined that this action is exempt from environmental review under the California Environmental Quality Act.
