IT IS HEREBY AGREED AS FOLLOWS:

IN THAT CERTAIN Contract No. 20-396 by and between San Bernardino County ("County") Probation Department ("Probation") and the Upland Unified School District ("District") which first became effective July 1,2020, the following changes are hereby made and agreed to:

I. SECTION VI. Term is hereby amended to read as follows:

This Contract shall be effective on July 1, 2020 and shall terminate June 30, 2022. This Contract may be terminated at any time without cause by District or by County upon written notice given to the other at least fifteen (15) days before the date specified for such termination. Any such termination date shall coincide with the end of the calendar month. In the event of such termination, each party shall fully pay and discharge all obligations in favor of the other accruing prior to the date of such termination. After termination, neither party shall have any further obligation to the other as a result of this Contract. Notwithstanding the forgoing, if either party to this Contract fails to perform any material obligation under this Contract, then, in addition to any other remedy provided by law, the other party may terminate this Contract immediately upon written notice given to the other party.

II. SECTION **X. Electronic Signature** is hereby added to read as follows:

This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The Parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name

is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.

All other terms, conditions, and covenants in Contract No. 20-396 remain in full force and effect. III.
