The Board of Supervisors of the County of San Bernardino, State of California,
acting in its capacity as the governing body of Board Governed County Service Area 70,
ordains as follows:

Employee Election Worker Program.

(b) California Elections Law requires that election workers attend a training session prior to each election. This training will be conducted by the Registrar of Voters during and after regular work hours. Employees will be encouraged to attend training

1 during their regular work hours.

2 (c) Any additional equipment or supplies necessary to carry out Election
3 Worker duties on Election Day will be provided by the Registrar of Voters. The Registrar
4 of Voters will keep affected department heads informed of employees who volunteer for
5 service on Election Day in terms of their attendance.

6 (d) The Registrar of Voters will reimburse Board Governed County Service
7 Area 70 for the compensation the employee receives while in election worker training.
8 Regardless of whether the hours worked as an Election Worker on or before Election Day
9 count as overtime, the Registrar of Voters will reimburse Board Governed County Service
10 Area 70 for any weekly overtime that applies due to the employee working as an Election
11 Worker on Election Day.

13 SECTION 2. The Board of Supervisors declares that it would have adopted this
14 ordinance and each section, sentence, clause, phrase, or portion of it irrespective of the
15 fact that any one or more sections, subsections, clauses, phrases or portions of it be
16 declared invalid or unconstitutional. If for any reason any portion of this ordinance is
17 declared invalid or unconstitutional, then all other provisions of it shall remain valid and
18 enforceable.

20 SECTION 3. This ordinance shall take effect thirty (30) days from the date of
21 adoption.
