Except for bridge widenings and bridge decks to be covered with an overlay, texture roadway surfaces of bridge decks, approach slabs, and sleeper slabs, and other roadway surfaces of concrete structures longitudinally by grinding and grooving.

Amend the Project Plans as follows:

Questions and Answers:

Q: Where are the steel jacking plates for the bearings located? Are the jacking plates paid under bid item 50 PTFE SPHERICAL BEARING?

A: See Addendum No. 2 – Attachment #2 for the revised hinge details.

Q: There are some TCEs expiring next year. Will the County be extending these TCEs?

A: The TCEs within the project will be renewed by the County for the duration of the construction.

Q: The project specifications require \$10,000,000 minimum coverage per occurrence for General Liability Insurance and as well as the Automobile Liability Insurance. But it also mentions \$2,000,000 in general aggregate limit of General Liability Insurance and \$2,000,000 combined single limit for Automobile Liability. That does not make sense. Per-occurrence limits are typically not higher than the general aggregate limit in a typical insurance policy. The general aggregate limit represents the total amount the insurer will pay out for all claims during the policy period, while per-occurrence limits are the maximum paid for a single incident. Please clarify.

A: Please see the answer from the San Bernardino County Risk Management Department – "The aggregate limits are typically double per occurrence limits. The aggregate limits shown in item 7-1.06G are the minimum requirements based on a construction contract under \$1,000,000. For a \$10,000,000 or higher construction project, Risk recommends \$10,000,000 in General Liability coverage and a \$20,000,000 aggregate. The per occurrence and aggregate limits can be met with an umbrella policy. In some larger contracts, an aggregate amount is not specified but an umbrella policy with a \$20,000,000 limit is required. Either approach is acceptable."

Q: Plan Sheet 16 shows the Type 60M/60MS Barrier transition at 48 ??, based on the stationing the barriers are slightly longer. Should the barriers follow the stationing with the additional length being per the 60M dimensions?

A: See Addendum No. 2 – Attachment #2 for revised plan sheet.

Q: Please provide a detail of the transition from the Type 842 barrier to the 60M barrier.

A: See Addendum No. 2 – Attachment #2 for detail.

Q: Regarding Section 13-4.03G: The Contractor is fully responsible for any damages done to public and private property from failing to contain water flows. This is a broad statement, we as the contractor can expect to receive "normal" flows of water and plan to divert water in way as to not affect adjacent properties, however as in the case of an event like Tropical Storm Hillary 2 years ago how can the Contractor be held responsible for an event that would be considered Force Majeure? Please clarify the extent of the Contractors responsibility.

A: The Contractor shall protect the existing improvements per the Caltrans Specifications regarding existing facilities. Also, the Contractor shall comply with the Caltrans Specifications for protecting work in the event of an Act of God or an Emergency Declaration.

Q: Section 13-3.01A of the Specifications states the Department has prepared a draft SWPPP for the project and must be used as a template. Please provide a copy of the draft SWPPP for review.

A: See Addendum No. 2 - Attachment #3

Q: Please clarify the type of material for the culverts to be removed.

A: See as-builts for more info, which states, "Exist. CMP Arch Culvert Plugged Ends with CC & left in-place".

Q: Please clarify the type for the new chain link fence on the project. The description for Bid Item 75 says CL-6 but construction notes on the plans say CL-8.

A: The bid item on the proposal page has been updated to CL-8 to match plans, included in Addendum No. 2.

Q: Please review specified location of Field Office; "office must be within 2 miles of Amboy" is most likely referring to another project.

A: Please refer to Addendum No. 1 regarding the location of the field office.

Q: Please include the Foundation Report as indicated in section 2-1.06B (table on SP-5).

A: See Addendum No. 1 - Attachment #4

Q: Please confirm this project is not a designated freeze-thaw area.

A: Confirmed. The project is not in a Freeze thaw area as stated by Caltrans.

Q: Please advise how the architectural treatment shown on plan sheet 114 is measured and paid.

A: This treatment is paid by Item #49, Concrete Surface Texture (Western Range Grass). Measurement is based on the final surface

Q: Per the architectural details on plan sheet 114, please confirm if this applies to the traffic side (interior face) of both the Type 732SW Mod and Type 842 concrete barriers.

A: Traffic side (interior face) on Type 842 barrier only

Q: Please be informed that the Existing contours haven't been revised on Grading plans in Addendum #1 as it was stated in the answers. Please provide the correct Grading plans.

A: Existing contour elevations were updated, included in Addendum No. 2.

Q: Revised Plan Sheet DD-2 was not included in Addendum #1 as stated in the Q&A.

A: DD-2 was updated, included in Addendum No. 2.

Q: Addendum 1 revised the quantity for Item 1 ?? Supplemental Work and removed the stipulated unit price. Please provide the unit price all Contractors are to enter for Item 1 based on the revisions.

A: See Addendum No. 2 – Attachment #1

Q: Please provide the unit price to be used for Bid Item 2 ?? Supplemental Work (Federal Trainee Program). A: See Addendum No. 2 – Attachment #1

Q: Due to this project bidding one day before a national holiday and a pending addenda, we respectfully request a postponement so that primes, subs, and suppliers can enjoy this traditionally week long mid year break.

A: Please submit the bid on the date and time as stated within this Addendum.

Q: Due to the bid time being 10:00AM, can the Contractor submit the CARB certificates in with the good faith documents? Typically the bid time is late afternoon which allows time for the Contractor to obtain the certificates.

A: The Contractor shall acknowledge the CARB Certification Form as stated within the Proposal pages before or by bid opening. The Contractor is responsible for reviewing the CARB Certification form in its entirety as well as their submitted proposal.

Q: Addendum No. 1 has multiple bid items designated (P) under the Final Pay Item (F) Column. Please provide guidance on what the (P) indicates.

A: Designation (P) has been removed, see Addendum No. 2 – Attachment #1

Q: Addendum No. 1 Q&A refers to the ??revised pier details No. 1 ??. There does not appear to be a revised detail provided in Addendum No. 1.

A: Will be provided with Addendum No. 2

Q: In the Rock Springs Road As-Built provided, the Typical Reinforced Concrete Box Section shown on sheet 3, has a crossed out note for the cutoff wall. Is it assumed that this 8 ?? deep cut off wall is in place and is it 8 ?? thick? If so, does the full depth of the cut off wall require removal? This same detail shows a 4 ?? cut off wall, but it does not appear to be to scale. Is this wall 1 ?? thick and 4 ?? deep? Does the full depth of this cutoff wall and its footing require removal?

A: The full removal of the existing concrete low water crossing is required, see as-builts for more information. This removal is paid for under Remove Concrete (SQYD)

Q: The Jacking plate details were not provided for the abutment in Addendum #1; will this be provided in Addendum #2 with the revised hinge detail?

A: Is provided within Addendum No.2.

Q: Per the Q&A, the 732SW barrier will have ??one 2 ?? conduit for electrical and one 4 ?? conduit for future utilities is to be provided, see Addendum #1 ??. Please provide the updated revised drawing.

A: Is provided within Addendum No.2.

Q: Addendum #1 states that the legend on sheet 81 was revised. Please provide the revised sheet 81.

A: See Addendum No. 2 - Attachment #2

Q: Can the Good Faith Effort be submitted in an electronic file? What email(s) should it be sent to?

A: The Good Faith Effort can be submitted via email, please submit the document to carlos.seanez@dpw.sbcounty.gov, Andrew.Truong@dpw.sbcounty.gov, and ASilao@dpw.sbcounty.gov.

Q: Does the EEO Certification require a signature from the contractor and subcontractors?

A: The EEO Certification form needs to be filled out for each of the subcontractors that qualify as stated within the form of the proposal; this form does not require a Sub Contractor and Prime Contractor signature.

Q: Can the EEO form for listed subcontractors be submitted after the bid opening?

A: Please see the previous answer regarding the EEO form as part of the proposal.

Q: Can the CARB certificates for listed subcontractors be submitted after the bid opening? Public Agencies have provided up to 10 days after the bid due date to submit CARB certificates for listed subcontractors.

A: The Prime Contractor shall include the CARB Certification Form within their bid proposal. It is acceptable for the subcontractor CARB certificates to be submitted within 10 Days from the bid opening.

Q: Please extend the bid opening from 7/3/25 by one week to allow sufficient time of 5 calendar days to submit the good faith effort as it is currently set around a holiday weekend.

Q: Reference is made to Plan Sheet G-3 / Sheet No. 37 of the Addendum 01 plans, and it appears the existing and finish contour grades remain unrevised. The grade busts identified in the original bid plans seem to still be present.

Q: Reference Pay Item Schedule. Please clarify what F.A. in the Unit of Measure column stands for.

A: The unit of measure for F.A. is Force Account, this bid item can only be accessed through an approved change order.

Q: Reference Pay Item schedule. Please clarify what (P) under the Final Pay Item column stands for.

A: Designation (P) has been removed, see Addendum No. 2 – Attachment #1

Q: Reference ??Jacking Detail ?? sheet 106. Please clarify quantity and locations of jacking plates.

A: Is provided within Addendum No.2.

Q: Reference Sheet 41 and San Bernardino County standard plan 209. Do headwalls require cable railing or chain link fencing on top?

A: No, headwalls do not require cable railing or chain link fencing on top.

Q: Does the County or either of the two City ??s own the land west of the Deep Creek Market? If not is there another staging available for the contractor to use for field offices?

A: The project includes a large TCE on the BNSF property that may be used for this purpose.

Q: Reference 8-1.04A in the Special Provisions. Valid proof of approved encroachment permit is required prior to construction. Please provide an estimated cost for this permit.

A: Please refer to each jurisdiction for their respective fees and requirements for issuance of an encroachment permit to construct this project. The County is not responsible for the payment or the issuance of the encroachment permit and the contractor shall bear all costs associated with obtaining all permits and all costs shall be included within the various items of bid for this project.

Q: Refence Q&A ??s in Addendum 1. Answer to moving construction joint in CIDH was provided along with statement revised pier detail No.1 would be provided. Please confirm no changes to original detail have been made other than showing an optional construction joint.

A: Is provided within Addendum No.2.

Q: Refence Q&A ??s in Addendum 1. Answer to concrete backfill typical section stated plan sheet DD-2 has been updated. Please provide updated plan sheet DD-2.

A: DD-2 was updated, included in Addendum No. 2.

Q: Reference Traffic Handling Plan sheets TH-1 through TH-15. Plans don ??t indicate temporary crash cushions are required however, Caltrans standard plans for temporary crash cushions are included in the specifications. Are temporary crash cushions required at the temporary K-Rail ends?

A: Per Caltrans Construction Manual 15' minimum offsets from the edge of an open traffic lane at the approach end of Type K temporary railing doesn't not require a crash cushion.

Q: Reference Special Provisions 5-1.36C(3). Specifications state the rearrangement of utilities is not anticipated work within the scope of the project. Please clarify what Pay Item 1 (Supplemental Work) is to include.

A: Bid Item #1 - Supplemental Work shall only be used for the scope of work as specified within these special provisions. The use of Force Account shall be approved by the Engineer prior the start of the proposed work within the project.

Q: Reference Pay Item 76 Chain Link Fence (Type CL-6), please confirm if this should be Type CL-6 or Type CL-8 in accordance with callouts on Sheet L-3 and L-4.

A: The bid item on proposal page has been updated to CL-8 to match plans, included in Addendum #2.

Q: Reference is made to Addendum 1, Plan Sheets DE-1, L-2, and L-3. It appears these plans still lack clear information regarding the limits of existing AC (asphalt concrete) demolition (between RS Line stations 25+00 and 29+00, 42+00 and 57+00). Please provide the missing demolition limits on the referenced plan sheets. A: Additional callouts have been provided in Addendum No. 2.
