AMENDMENT NO. 2

WHEREAS, Advanced Sterilization Products ("ASP") and San Bernardino County on behalf of Arrowhead Regional Medical Center ("County") entered into a Service Agreement ("Agreement"), fully executed on November 16, 2021, with a term of December 15, 2021 to December 14, 2022 for the preventative and maintenance service of certain Sterrad equipment ("Equipment"); and

WHEREAS, the parties subsequently entered into Amendment No. 1 to extend the term of the Agreement through December 14, 2023; and

WHEREAS, the parties now desire to further amend the Agreement to extend the term of the Agreement and to modify the list of equipment to receive service under the Agreement; and

NOW THEREFORE, effective as of December 15, 2023, the parties agree to amend the Agreement as follows:

1. The term of the Agreement is extended through December 14, 2025 and the total Agreement amount shall be increased by \$45,742.48 for a total contract amount of \$126,834.48, consistent with the following table for the additional period of December 15, 2023 through December 14, 2025:

- 3. All other terms and conditions of the Agreement shall remain in full force and effect.
- 4. ASP has disclosed to the County using Attachment 1 to this Amendment, whether it has made any campaign contributions of more than \$250 to any member of the County Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney] within the 12 months before the date this Amendment was approved by the Board of Supervisors. ASP acknowledges that under Government Code section 84308, ASP is prohibited from making campaign contributions of more than \$250 to any member of the Board of Supervisors or County elected officer for 12 months after the County's consideration of the Amendment.

In the event of any additional proposed amendments to the Agreement, ASP will provide the County a written statement disclosing any campaign contribution(s) of more than \$250 to any member of the Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed amendment.

Campaign contributions include those made by any agent/person/entity on behalf of ASP or by a parent, subsidiary or otherwise related business entity of ASP.

5. This Amendment No. 2 may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.

ATTACHMENT 1 Senate Bill 1439 Contractor Information Report

DEFINITIONS

Actively supporting the matter: (a) Communicate directly, either in person or in writing, with a member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, District Attorney, Auditor-Controller/Treasurer/Tax Collector] with the purpose of influencing the decision on the matter; or (b) testifies or makes an oral statement before the County in a proceeding on the matter; or (c) communicates with County employees, for the purpose of influencing the County's decision on the matter; or (d) when the person/company's agent lobbies in person, testifies in person or otherwise communicates with the Board or County employees for purposes of influencing the County's decision in a matter.

Agent: A third-party individual or firm who is representing a party or a participant in the matter submitted to the Board of Supervisors. If an agent is an employee or member of a third-party law, architectural, engineering or consulting firm, or a similar entity, both the entity and the individual are considered agents.

Otherwise related entity: An otherwise related entity is any for-profit organization/company which does not have a parent-subsidiary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.

For purposes of (2), "shared management and control" can be found when the same person or substantially the same persons own and manage the two entities; there are common or commingled funds or assets; the business entities share the use of the same offices or employees, or otherwise share activities, resources or personnel on a regular basis; or there is otherwise a regular and close working relationship between the entities.

<u>Parent-Subsidiary Relationship:</u> A parent-subsidiary relationship exists when one corporation has more than 50 percent of the voting power of another corporation.
