Amendment to Professional Services Agreement with Inland Medical Rehabilitation, Inc. for Rehabilitation Services

**RECOMMENDATION(S)**

Approve **Amendment No. 1** to Professional Services **Agreement No. 19-838** with Inland Medical Rehabilitation, Inc., increasing the total contract amount by \$80,000 plus variable costs from \$400,000 plus variable costs to \$480,000 plus variable costs, and extending the contract term by one-year, for a total contract term of January 1, 2020, through December 31, 2025. **COUNTY AND CHIEF EXECUTIVE OFFICER GOALS & OBJECTIVES**

**Provide for the Safety, Health and Social Service Needs of County Residents.**

**FINANCIAL IMPACT**

Approval of this item will not result in the use of Discretionary General Funding (Net County Cost). The cost of \$80,000 plus variable costs are funded by State Medi-Cal, Federal Medicare, private insurances, and other departmental revenue. Funding sources may change in the future pending any legislative activity related to the repeal and/or replacement of the Affordable Care Act. Adequate appropriation and revenue have been included in Arrowhead Regional Medical Center's (ARMC) 2024-25 budget and will be included in 2025-26 recommended budget.

**BACKGROUND INFORMATION**

Approval of the Amendment to Agreement No. 19-838 with Inland Medical Rehabilitation, Inc. (IMH) will extend the rehabilitation services being provided at ARMC for an additional year. Rehabilitation is a medical specialty that helps people regain function and improve their quality of life after an injury or disease. These services being provided by IMH are essential to the recovery and overall well-being of many ARMC patients.

On December 17, 2019 (Item No. 6), as the result of a non-competitive procurement, the Board of Supervisors (Board) approved Agreement No. 19-838 (Agreement) with Inland Medical Rehabilitation, Inc (IMH) to provide rehabilitation services at ARMC in the amount of \$80,000 per year plus variables for the contract term of January 1, 2020, through December 31, 2024.

ARMC recommends approval of the Amendment to ensure County residents and patients have the necessary access to rehabilitation services at ARMC.


