THIS SUPPLEMENTAL AGREEMENT (the "Supplement") is made as of _____, by and between UNION PACIFIC RAILROAD COMPANY, a Delaware corporation ("**Railroad**") and the COUNTY OF SAN BERNARDINO, CALIFORNIA ("**Agency**"), to be addressed at 825 East Third Street, San Bernardino, CA 92415

RECITALS

By instrument dated September 21st, 2022 Union Pacific Railroad Company and the Agency entered into an agreement for engineering services identified by the UPRR Project number above (the "**Agreement**").

The Agency has requested a Supplemental Agreement to include an addendum for additional funding for engineering services as shown on the Exhibit Addendum attached hereto.

AGREEMENT

NOW, THEREFORE, IT IS MUTUALLY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

SECTION 1 - AMENDMENT OF THE AGREEMENT

Railroad amends the Agreement to include the attached Exhibit A.

The Agreement is amended to include the updated Exhibit A "Project Description and Location" with the additional location: Napa Street, DOT 978415L, Alhambra Sub, MP 526.267, as shown on the amended Exhibit A, attached hereto and hereby made a part thereof to the Agreement, which shall be, and hereby is amended to include the additional location.

This Supplemental Agreement shall be effective as of the instrument date above.
