RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY TO ESTABLISH A SPEED ZONE ON LYTLE CREEK ROAD, FONTANA AREA

On Tuesday July 26, 2022, on motion of Supervisor Baca Jr., duly seconded by Supervisor Rutherford and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

Due to conditions affecting the welfare of the public utilizing Lytle Creek Road in the Fontana area, the Board of Supervisors, pursuant to an engineering and traffic survey, deems it necessary to:

- 1. Rescind an existing 35 mile per hour speed zone on Lytle Creek Road (510900-030) from 4.24 miles north of Sierra Avenue to 5.24 miles north of Sierra Avenue, pursuant to County Code section 52.0123(b), as the conditions for which this speed limit was determined have changed.
- 2. Establish a 35 mile per hour speed zone on Lytle Creek Road (510900-030), from 4.24 miles north of Sierra Avenue to 5.15 miles north of Sierra Avenue, pursuant to County Code section 52.0123(b), as this speed limit is the most appropriate facilitate the orderly movement of traffic and is reasonable and safe.
- 3. Rescind an existing 25 mile per hour speed zone on Lytle Creek Road (510900-030) from 5.24 miles north of Sierra Avenue to 6.30 miles north of Sierra Avenue, pursuant to County Code section 52.0123(b), as the conditions for which this speed limit was determined have changed.
- 4. Establish a 25 mile per hour speed zone on Lytle Creek Road (510900-030), from 5.15 miles north of Sierra Avenue to 6.30 miles north of Sierra Avenue, pursuant to County Code section 52.0123(b), as this speed limit is the most appropriate facilitate the orderly movement of traffic and is reasonable and safe.
- 5. Direct the County Road Commissioner to perform such acts as are necessary to implement the terms of this resolution.
