

RESOLUTION NO. 2024-77

RESOLUTION OF THE BOARD OF DIRECTORS OF BLOOMINGTON RECREATION AND PARK DISTRICT FOR ADOPTION OF THE FISCAL 2024-25 BUDGET

On Tuesday, June 11, 2024, on motion of Director Baca, Jr., duly seconded by Director Hagman and carried, the following resolution is adopted by the Board of Directors of Bloomington Recreation and Park District.

WHEREAS, pursuant to Section 29080 of the Government Code, a notice was published on May 22, 2024, May 23, 2024, and May 28, 2024, in a newspaper of general circulation throughout the County regarding the availability of the 2024-25 Recommended Budget documents, on file with the Secretary of the Board. The notice also set forth that on June 11, 2024, at 10:00 a.m., a public hearing would be conducted on the 2024-25 Recommended Budget for the Bloomington Recreation and Park District. The documents were available to the public on May 21, 2024, at least 10 days prior to the public hearing. The notice further set forth that any member of the public may appear at the hearing and be heard regarding any item in the Recommended Budget or for inclusion of additional items. Finally, the notice set forth the requirement that all proposals for revisions to the Recommended Budget should be submitted in writing to the Secretary of the Board before the close of the public hearing.

WHEREAS, pursuant to Sections 29080 through 29092 of the Government Code, the Board of Directors of the Bloomington Recreation and Park District on June 11, 2024, held a duly noticed hearing for the purpose of considering the 2024-25 Recommended Budget, including any financing requirements of the Recommended Budget, less deletions and reductions, plus such additions and increases as may be made by order of the Board during the budget hearing and prior to the adoption of this Resolution.

NOW, THEREFORE, BE IT RESOLVED, the Board of Directors of the Bloomington Recreation and Park District hereby finds, determines, declares, and resolves as follows:

- Section 1. All of the above recitals are true and correct.
- Section 2. A duly noticed public hearing of the 2024-25 Recommended Budget was held. All requests regarding the Recommended Budget were received and considered by the Board.
- Section 3. At the conclusion of the hearing, and after making any revisions of, deductions from, or increases or additions to, the Recommended Budget (as presented in the Recommended Budget Book and Attachment A) that it deems advisable, pursuant to Government Code Sections 29089 and 29090, the Board hereby refers to the financing uses in the Recommended Budget and adopts the Budget as finally determined ("Adopted Budget"). The Chief Executive Officer of San Bernardino County is hereby authorized to make changes to the Adopted Budget only to accommodate actual fund balance as determined at year end and any technical balancing adjustments to appropriation, revenue, and available reserves which has been adopted by The Board of Directors. The Adopted Budget as finally determined meets the requirements set for in Government Code Section 29089.
- Section 4. Pursuant to Government Code section 29089(f), the Bloomington Recreation and Park District hereby makes provisions for five fund balance classifications (required as a result of the adoption and implementation of GASB 54. The provisions for use of these classifications of fund balance in 2024-25 are detailed below:

Non-spendable Fund Balance: Not available for appropriation in any of the funds.
