

**RESOLUTION NO. 2025-132**

**RESOLUTION OF THE BOARD OF SUPERVISORS  
OF SAN BERNARDINO COUNTY TO ACCEPT SEGMENTS OF VALENCIA AVENUE IN THE  
FONTANA AREA INTO THE COUNTY MAINTAINED ROAD SYSTEM**

On Wednesday, June 10, 2025, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS**, section 941 of the Streets and Highways Code provides that no public or private road shall become a County highway until and unless accepted by appropriate action of the Board of Supervisors, or the Board's designee; and

**WHEREAS**, Valencia Avenue from Cherry Avenue east for approximately 0.06 miles and Valencia Avenue from Beech Avenue east to Sultana Avenue in the Fontana area has been evaluated by Department of Public Works, Operations Division and has been constructed, inspected and approved to County standards; and

**WHEREAS**, right-of-way for Valencia Avenue from Cherry Avenue east for approximately .06 miles and Valencia Avenue from Beech Avenue east to Sultana Avenue in the Fontana area has been dedicated to San Bernardino County; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of San Bernardino County that the accepted limits in the Oak Hills area (listed below) are necessary to the public convenience and, therefore, are accepted into the County Maintained Road System.
