IN THAT CERTAIN **Contract No. 20-487** by and between San Bernardino County, a political subdivision of the State of California, and Contractor for certain substance use disorder services, which Contract first became effective July 1, 2020, the following changes are hereby made and agreed to:

- I. ARTICLE IV <u>FUNDING</u>, paragraphs K and L are hereby amended to read as follows:
