Dear Dr. Kelley:

The Department of Health Care Services (DHCS), Federal Grants Branch, has reviewed and approved the Budget Change Revision (BCR) request received on 9/09/2021, which reflects the additional funding awarded to San Bernardino County's SFY 2021-22 Projects for Assistance in Transition from Homelessness (PATH) grant application. The new PATH allocation amount for San Bernardino County is \$508,762.

Please note that DHCS is not requiring the County to adjust budgeted match funding to account for the additional federal funding amount. This requirement has been met at the state level.

Any subsequent BCR will require the County to budget match funding at a level not less than one dollar for every three dollars of federal funding expended.
