

**RESOLUTION NO. 2023-54**

**RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, APPROVING THE RESCHEDULED SALE OF TAX-DEFAULTED PROPERTY BY INTERNET PUBLIC AUCTION ON OR AFTER AUGUST 12, 2023**

On Tuesday, May 9, 2023, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS**, the Tax Collector notified the San Bernardino County Board of Supervisors on March 14, 2023, of its intention to sell at public auction tax-defaulted properties which were subject to the Tax Collector's power of sale pursuant to Revenue and Taxation Code section 3691; and

**WHEREAS**, the Board of Supervisors subsequently adopted Resolution No. 2023-32, approving Tax Collector's proposed sale of the tax-defaulted properties (Tax Sale #373) by internet public auction on or after May 13, 2023; and

**WHEREAS**, the Tax Collector was unable to send notice of the proposed sale to parties of interest not less than 45 days prior to the sale as required by Revenue and Taxation Code section 3701 and requests to reschedule the public auction to on or after August 12, 2023, to meet the notification requirements; and

**WHEREAS**, the Tax Collector has submitted the revised schedule of properties for Tax Sale #373 attached hereto and incorporated by reference, which provides a description and minimum price of the tax-defaulted properties to be sold by the Tax Collector at public auction; and

**WHEREAS**, the Tax Collector requests approval to sell these tax-defaulted properties at public auction, via the internet, on or after August 12, 2023, in accordance with Chapter 7 of Part 6 of Division 1 of the Revenue and Taxation Code;

**NOW, THEREFORE, BE IT RESOLVED**, by the San Bernardino County Board of Supervisors as follows:

1. The Board hereby approves the Tax Collector's proposed sale (Tax Sale #373) of the tax-defaulted properties listed on the attached schedule by internet public auction on or after August 12, 2023.
2. The Tax Collector is directed to sell the above-described tax-defaulted properties as provided by law, pursuant to Chapter 7 of Part 6 of Division 1 of the Revenue and Taxation Code.
3. This Resolution repeals and supersedes Resolution No. 2023-32, adopted by the Board of Supervisors on March 14, 2023.
