**RESOLUTION OF THE BOARD OF SUPERVISORS
OF THE COUNTY OF SAN BERNARDINO TO
TERMINATE MAINTENANCE OF
WALNUT STREET, BLOOMINGTON AREA**

On Tuesday February 9, 2021, on motion of Supervisor Baca, duly seconded by Supervisor Rutherford and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, Section 954.5(a) of the Streets and Highways Code, provides that the Board of Supervisors of the County of San Bernardino (Board) may, by resolution, terminate the maintenance of any county highway if it finds that the highway is unnecessary for the public convenience; and,

WHEREAS, Section 954.5(b) of the Streets and Highways Code allows the Board to terminate maintenance of any County highway unnecessary for public convenience after hearing evidence at a public hearing; and,

WHEREAS, a public hearing was conducted on the above described date to consider evidence that Walnut Street, from Slover Avenue southerly to Otilla Street, is unnecessary for the public convenience; and

NOW THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of San Bernardino finds and determines that all of the recitals contained hereinabove are true and correct and based on the evidence presented Walnut Street, from Otilla Street north 0.06 mile, in the Bloomington area, is unnecessary for public convenience due to it having intermittent traffic of low volume and that it does not provide primary access to occupied properties.

BE IT FURTHER RESOLVED, by the Board of Supervisors of the County of San Bernardino, that the highway listed below shall no longer be maintained by the County and is hereby deleted from the County Maintained Road System:
