**AMENDMENT No. 9**

Contract No 15-501 to provide law enforcement service in the form of a Deputy Sheriff, acting as a School Resource Officer to the Victor Valley Union High School District is hereby amended, effective July 1, 2024, as follows: (1) by replacing the first sentence of Section V. TERM and TERMINATION with the sentence below to change the contract end date from June 30, 2024 to June 30, 2025; and (2) to replace the Schedule A referred to in Sections I.A. and II.A with the Schedule A attached hereto and incorporated herein by this reference.

**V. TERM AND TERMINATION**
