

**RESOLUTION NO. 2024-56**

**RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF COUNTY SERVICE AREA 70, ZONE TV-4 (WONDER VALLEY TELEVISION), FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2024-25**

On Tuesday, June 11, 2024, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone TV-4, therefore, hereby finds and determines:

(a) That on November 7, 1996, the electors of County Service Area 70, Zone TV-4, duly authorized a special tax levy for television services.

(b) That the amount of such tax shall not exceed \$5 per parcel, per year.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone TV-4, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2024-25 shall be set at \$5 per parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective on July 1, 2024.

(d) That the Auditor-Controller/Treasurer/Tax Collector is directed to place the direct charge levies on the applicable tax roll.

## ATTACHMENT C

Adopt Resolution setting a special tax for County Service Area 70, Zone TV-4 (Wonder Valley Television) at \$5 per parcel, per year.

**Background:** On November 7, 1996, the electorate of County Service Area 70, Zone TV-4 (Wonder Valley Television), approved a special tax authorizing a \$5 per parcel, per year charge to fund television services. Based on approximately 4,817 parcels, the tax is anticipated to generate approximately \$24,085 for FY 2024-25, in relation to estimated total proposed appropriations of \$74,711. The funds provide television signals to the entire Wonder Valley area under agreement between County Service Area 70, Zone TV-4 and County Service Area 70, Zone TV-5 (Mesa Television).
