AMENDMENT TO AGREEMENT

This Amendment to Agreement (this "Amendment") is made as of the date last set forth on the signature page hereto ("Amendment Effective Date") by and between UpToDate, Inc., with its principle business location at 230 3rd Avenue, Waltham, MA 02451 ("UpToDate"), and County Of San Bernardino Department Of Public Health, with its principle business location at 172 W 3rd St, San Bernardino, California 92415-0320, United States, (the "Customer", and together with UpToDate, the "Parties").

RECITALS

- A. UpToDate and Customer are parties to that certain Agreement dated October 23, 2019, Contract No. 00004679, as modified by Contract No. 00013278 (collectively, the "Agreement"), pursuant to which Customer has subscribed for the *UpToDate Anywhere* license.
- B. UpToDate and Customer wish to amend the Agreement to extend the term of the Agreement in exchange for Customer's payment of the Subscription Fees (as defined below) as set forth in this Amendment.
- C. Capitalized terms used but not defined in this Amendment shall have the meaning given to them in the Agreement.

NOW, THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. **Subscription Fees.** Customer shall pay to UpToDate the additional Subscription Fee of \$10,467.00 USD (plus tax where applicable) for the extension of the term of the Agreement (the "Term") by one year, in accordance with the terms applicable to fees set forth in the Agreement. The payment of the additional subscription Fee shall be paid within thirty (30) days of the Amendment Effective Date.
2. **Term.** The Term is hereby extended for one year, beginning December 1, 2021 and ending November 30, 2022.


