SINGLE SITE AGREEMENT

This SINGLE SITE agreement is between Mentor Worldwide LLC, a Delaware limited liability company (the "Company"), and San Bernardino County on behalf of Arrowhead Regional Medical Center (Mentor Account # 389263), a political subdivision organized and existing under the constitution and the laws of the State of California (the "Customer").

The Company sells medical devices and supplies. The Customer operates a hospital or surgery center.

The Company will provide the Customer, as permitted by the discount exception to the federal anti-kickback statute (42 U.S.C. § 1320a-7b(b)(3)) and/or the discount safe harbor to the federal anti-kickback statute (42 C.F.R. § 1001.952(h)), with Price Concessions on purchases under this agreement if certain conditions are met.

The parties agree as follows:

Article 1 PRODUCT TERMS AND PRICING

1.1 Product Pricing. The pricing (including any discount at the time of sale (a "Discount") and any retrospective payment (a "Rebate"), each, a "Price Concession") is set forth in Schedule A. Only products covered by Schedule A (the "Products") and purchased under this agreement are eligible for Price Concessions.

1.2 Customer Eligibility. The Customer will not be entitled to purchase any Product set forth in Schedule A unless, at the time of purchase, the Customer operates a hospital or surgery center located in any state of the United States or the District of Columbia; does not purchase Products directly or indirectly under another agreement with the Company or its affiliates; and serves only the Customer's patients.

1.3 Patent Risk/Benefit Information. The sale and distribution of Company breast implant devices is restricted to users and/or user facilities that provide information to patients about the risks and benefits of the breast implant device in the form and manner specified in the approved labeling provided by the Company (the "Patient Checklist Process"). The Customer will not provide a Company breast implant Product for use by a physician unless the physician (i) has provided the Company with a written affirmation that they will complete the Patient Checklist Process prior to each Company breast implant Product procedure, and (ii) has completed the Patient Checklist Process with the patient prior to that procedure. The Customer must maintain copies of the completed Patient Checklists that are part of the Patient Checklist Process per its document retention policy and, upon the Company's request, unless prohibited by applicable law, permit the Company or its designee to review those records to verify that the Customer has complied with its obligations under this section. Failure to comply with these requirements may lead to loss of access to Company breast implant devices.

1.4 Direct Purchases. (a) If a Participant purchases a Product directly from the Company or its affiliate, then delivery of such Product will be F.O.B. Origin, title transfer and Participant acceptance of such Product occurring upon transfer of Product to the carrier. Payment terms are net 30 days. Policies in effect at the Company or its affiliate, as applicable, (i) at the time of purchase regarding order and payment, will apply to any such purchase, and (ii) at the time of return, will apply to any Product returns. In the event any policies conflict with the terms of this agreement, the terms of this agreement shall control. The Customer and the Participants will neither deduct nor set-off, from payments under this agreement, amounts allegedly owed to the Customer or a Participant by the Company or its affiliates under a separate agreement or cause of action.

(b) Company shall accept all payments from Customer via electronic funds transfer (EFT) directly deposited into Company's designated checking or other bank account. Company shall promptly comply with directions and accurately complete forms provided by Customer required to process EFT

payments. Customer is exempt from Federal excise taxes and no payment shall be made for any personal property taxes levied on Company or on any taxes levied on employee wages. Customer shall only pay for any State or local sales or use taxes on the services rendered or equipment and/or parts supplied to Customer pursuant to this agreement.

Article 2 GENERAL PROVISIONS

2.1 Term and Termination. This three (3) year agreement is effective as of the date fully executed **May 24, 2022** (the "Effective Date") and expires on the third anniversary of the Effective Date **May 23, 2025** (the "End Date"). Either party may terminate this agreement at any time by giving 30 days' advance notice to the other party. This General Provisions Article, along with any accrued rights and responsibilities, will survive termination or expiration of this agreement.

2.2 Entire Agreement. All exhibits and schedules attached hereto and referenced herein are made a part of this agreement. This agreement constitutes the entire agreement between the parties concerning the subject matter of this agreement and supersedes all prior negotiations and agreements between the parties concerning the subject matter of this agreement. The terms of any purchase order, invoice, or similar document used to implement this agreement shall be subject to and shall not modify this agreement.

2.3 Amendment. Except as otherwise expressly stated herein, this agreement may only be amended in writing and executed by the parties.

2.4 Assignment. Except as provided in this section, neither party may assign, directly or indirectly, this agreement or any of its rights or obligations under this agreement, either voluntarily or involuntarily (whether by merger, acquisition, consolidation, dissolution, operation of law, change of control, or otherwise) without the prior written consent of the other party.

2.5 Notices. Notices under this agreement must be in writing, signed by the sending party, and sent to the address below by one of the following methods: personal delivery; registered or certified mail, in each case return receipt requested and postage prepaid; or nationally recognized overnight courier, with all fees prepaid. A notice under this agreement is effective upon receipt or refusal of delivery by the other party. The address listed below may be changed by notice in accordance with this section. A failure to deliver a courtesy copy of a notice does not constitute a notice failure.

2.6 Waiver. No provision of this agreement may be waived except in writing and signed by the party against whom the waiver is sought to be enforced. No failure to enforce any provision of this agreement constitutes a waiver of future enforcement of that provision or of any other provision of this agreement.

2.7 Relationship of the Parties. For purposes of this agreement, each party is an independent contractor. This agreement does not create a partnership, association, or other business entity. Neither

party has any authority to act for or to bind the other.

2.8 No Third-Party Beneficiaries. No one other than the Company and the Customer has any rights, or is entitled to any remedies, under this agreement.

2.9 Publicity and Trademarks. Each party will not, and will cause its affiliates not to, issue any press release or make any announcement regarding this agreement nor use the name or any trademark or service mark of the other party or any of its affiliates without the prior written consent of the other party.

2.10 Confidentiality. (a) Each party shall hold the following "Confidential Information" in strict confidence and not disclose the same to any other person or entity except as provided herein: all Product data, trade secrets, financial data, business plans; and all information derived from the foregoing.

(b) Notwithstanding the above:

- (1) This agreement is subject to the San Bernardino County Sunshine Ordinance, County Code of Ordinances Section 19.0101, California Government Code 54950 et seq. ("Brown Act"), and California Public Records Act (Government Code Section 6250) (collectively, "Regulations"). Customer acknowledges the Company's assertion that its pricing information as defined and provided in specific this pricing agreement is a trade secret as defined by California Civil Code §3426.1(d) and in accordance with the California Public Records Act §6254(k). As such, Customer will use reasonable means to ensure that such information is safeguarded but will not be held liable for disclosure of the information where required by law. Company represents that it has a good faith belief that such information is exempt from disclosure under the Regulations and agrees to reimburse Customer for, and to indemnify, defend, and hold harmless Customer, its officers, employees, and agents, from and against any and all claims, damages, losses, liabilities, suits, judgments, fines, penalties, costs, and expenses, including without limitation, attorneys' fees, expenses, and court costs of any nature arising from or relating to Customer's non-disclosure of any such information.
- (2) A party may disclose Confidential Information to the personnel within its organization and its legal and accounting advisors that require the Confidential Information in connection with the party's rights and obligations under this agreement, provided that the disclosing party requires any such recipient to use the information solely for these purposes and to keep it strictly confidential, except where disclosure is required by law.
- (3) Company may disclose Confidential Information as required by law, provided that Company provides reasonable prior notice to Customer to enable Customer to attempt to prevent or limit the disclosure and Company reasonably cooperates with Customer upon request in seeking relief from or limiting the disclosure. If Customer receives a subpoena, other validly issued administrative or judicial process, or public records request requesting Confidential Information of Company, it will, to the extent legally permissible, promptly notify Company and if requested by Company, tender to Company the defense of the subpoena or process. Unless the subpoena or process is timely limited, quashed or extended, Customer will then be entitled to comply with the request to the extent permitted by law.
- (4) The Company may disclose this agreement and Confidential Information related to this agreement: to any prospective buyer of rights with respect to a Product, provided that such buyer agrees in writing to use the information solely in that capacity and to keep it strictly confidential; to its affiliates; and to any entity that manufactures, markets, co-markets, or distributes any Product, provided that any such entity uses the information solely for these purposes and keeps it strictly confidential.
- (5) Neither party shall be obligated to hold the following information in confidence: information that is or becomes publicly available through no fault of the recipient; information developed by a party without using any Confidential Information; information lawfully possessed by a

party before receipt from the disclosing party; and information lawfully disclosed to a party on a non- confidential basis from a person or entity that is not bound by a duty of confidentiality.

- (6) A party may disclose Confidential Information with the prior written consent of the other party.
- (7) Pursuant to the Health Insurance Portability and Accountability Act of 1996 (HIPAA) and the Health Information Technology for Economic and Clinical Health (HITECH) Act, regulations have been promulgated governing the privacy of individually identifiable health information. The HIPAA Privacy Rule and Security Rule specify requirements with respect to contracts between a Covered Entity and its Business Associates. Company shall negotiate in good faith, execute and comply with an agreed to business associate agreement where required by law.

2.11 Force Majeure and Product Shortage. Noncompliance with any obligation under this agreement due to an event of force majeure or any other cause beyond the reasonable control of the entity affected will not constitute a breach of this agreement. In the event of a shortage of Product, the Company and its affiliates reserve the right to allocate Products among their customers in any manner that they, in their sole discretion, determine is reasonable.

2.12 Changes in Products. If a Product is discontinued, the regulatory status of a Product changes or the Company and its affiliates cease to market or co-market a Product, then the Company may delete that Product from this agreement by notice to the Customer.

2.13 Audit. In order to verify that the Customer has complied with its obligations under this agreement, the Company may, subject to all applicable laws, audit all relevant books and records of the Customer. Audits will be on reasonable notice, during regular business hours, and limited to one in any 12-month period. Unless in response to a governmental investigation, audits will be limited to the purchases of Products within three years prior to the date of the audit request. The County, State and Federal government shall have absolute right to subpoena and review all records, books, papers, documents, corporate minutes, and other pertinent items as requested, and shall have absolute right to monitor the performance of Company in the delivery of services provided under this agreement. Company shall give full cooperation, in any auditing or monitoring conducted. Company shall cooperate with Customer in the implementation, monitoring, and evaluation of this agreement and comply with any and all reporting requirements established by Customer. All records pertaining to services delivered and all fiscal, statistical and management books and records shall be available for examination and audit by Customer representatives for a period of three years after final payment under this agreement or until all pending County, State and Federal audits are completed, whichever is later.

2.14 Compliance with Law. In performing their obligations under this agreement, the Company and the Customer shall comply with all applicable federal and state laws and regulations, including without limitation the Federal Food, Drug and Cosmetic Act, the Prescription Drug Marketing Act, equal-opportunity laws, and fraud and abuse laws.

2.15 Pricing Disclosure. (a) The Customer acknowledges that, by law, it is required to disclose, in any cost reports or claims for reimbursement submitted to Medicare, Medicaid, or certain other health care programs, the cost (including, but not limited to, Price Concessions or any other price reductions) of any Product purchased under this agreement and, on request, provide to the U.S. Department of Health and Human Services and any state agencies, any invoices, coupons, statements, and other documentation reflecting such costs for Products. The Customer may receive subsequent documentation under some programs reflecting adjustments or allocations to the Price Concessions available hereunder.

(b) In preparing any documentation referred to in Section 2.15(a), the Customer may be required to evaluate as a discount, for cost-reporting purposes, the value of any Product listed as \$0.00 on any invoice.

(c) The Customer should not include as a discount, for cost-reporting purposes, the value of any item that is designated as a sample, or that the Customer knows constitutes a sample, nor

should it seek reimbursement for any such items.

(d) The Company recommends that the Customer retain a copy of this agreement and any other documentation provided by the Company regarding any Price Concessions under this agreement.

(e) The Customer may request additional information from the Company to meet its reporting or disclosure obligations by writing to the Company at the address stated in Section 2.5 (Notices) of this agreement.

2.16 Government Program Participation. The Company represents that it has not been excluded from participating in any "federal health care program", as defined in 42 U.S.C. § 1320a-7b(f), or in any other federal or state government payment program and that it is eligible to participate in the foregoing programs. The Customer represents that it has been excluded from participating in any "federal health care program", as defined in 42 U.S.C. § 1320a-7b(f), or in any other federal or state government payment program and that each is eligible to participate in the foregoing programs. If either party is excluded from participating in, or becomes otherwise ineligible to participate in, any such program during the term of this agreement, then such party will notify the other party of that event within 30 days. Upon occurrence of that event, whether or not such notice is given, either party may terminate this agreement effective upon written notice to the other party.

2.17 Improper Consideration. Company shall not offer (either directly or through an intermediary) any improper consideration such as, but not limited to cash, discounts, service, the provision of travel or entertainment, or any items of value to any officer, employee or agent of Customer in an attempt to secure favorable treatment regarding this agreement. Customer, by written notice, may immediately terminate this agreement if it determines that any improper consideration as described in the preceding paragraph was offered to any officer, employee or agent of Customer with respect to the proposal and award process. This prohibition shall apply to any amendment, extension or evaluation process once a contract has been awarded. Company shall immediately report any attempt by a Customer officer, employee or agent to solicit (either directly or through an intermediary) improper consideration from Company. The report shall be made to the supervisor or manager charged with supervision of the employee or the San Bernardino County Administrative Office. In the event of a termination under this provision, Customer is entitled to pursue any available legal remedies.

2.18 Dispute Resolution. (a) This Agreement shall be deemed to be made and entered into pursuant to the laws of the state of California without giving effect to its choice of law principles. In the event of any dispute, claim, question or disagreement arising from or relating to this agreement or breach thereof, the parties hereto shall use their best efforts to settle the dispute, claim, question or disagreement. To this effect, they shall consult and negotiate with each other in good faith and, recognizing their mutual interests, attempt to reach a just and equitable solution satisfactory to both parties.

(b) Except for actions for equitable relief, or for infringement of intellectual property, or for enforcement of provisions of this section or for any dispute concerning an amount of less than \$10,000, in the event any Dispute cannot be resolved through good faith negotiation, either party shall submit to the other party a request for mediation of such Dispute using a professional mediator from the American Arbitration Association ("AAA") or a like organization selected by agreement or, absent agreement, through selection procedures administered by the AAA. Within a period of 45 days after the request for mediation, the parties shall convene with the mediator, with business representatives present, for at least one session to attempt to resolve the Dispute. The mediation shall be held in California. Each entity has the right to pursue provisional relief from any court, such as attachment, preliminary injunction, replevin, etc., to avoid irreparable harm, or maintain the status quo, even though mediation has not been commenced or completed.

2.19 Damages Cap. Excluding Customer's open accounts payables balance and liabilities related to third party claims subject to indemnification obligations pursuant to Section 2.24 Indemnity or claims based on gross negligence, willful misconduct, or violations of law, the liability of either party to the other party hereto arising out of or resulting from performance or non-performance under this Agreement shall be limited to five million dollars (US\$5,000,000) ("Damages Cap").

2.20 Governing Law; Venue; Attorneys' Fees. This agreement shall be governed by and construed according to the laws of the State of California. The parties acknowledge and agree that this agreement was entered into and intended to be performed in San Bernardino County, California. The parties agree that the venue of any action or claim brought by any party to this agreement will be the San Bernardino County Superior Court, San Bernardino District. Each party hereby waives any law or rule of the court, which would allow them to request or demand a change of venue. If any action or claim concerning this agreement is brought by any third party and filed in another venue, the parties hereto agree to use their best efforts to obtain a change of venue to the San Bernardino County Superior Court, San Bernardino District. If any legal action is instituted to enforce any party's rights hereunder, each party shall bear its own costs and attorney fees, regardless of who is the prevailing party. This paragraph shall not apply to those costs and attorney fees directly arising from a third-party legal action against a party hereto and payable under indemnification and insurance requirements.

2.21 Own Use. The Customer must use the Products solely on their patients, staff, employees, students and their respective dependents. The Customer will not resell any Products, including, without limitation, in retail outlets or to any affiliate.

2.22 Accuracy of Reports. The Customer will ensure that all reports that it is required to provide to the Company to implement this agreement are complete and accurate. Company shall maintain all records and books pertaining to the delivery of products under this agreement and demonstrate accountability for agreement performance. All records shall be complete and current and comply with all agreement requirements. Failure to maintain acceptable records shall be considered grounds for withholding of payments for invoices submitted and/or termination of the agreement. All records pertaining to this agreement shall be kept in a generally acceptable accounting format. Records should include primary source documents. Fiscal records shall be kept in accordance with Generally Accepted Accounting Principles and must account for all funds, tangible assets, revenue and expenditures. Fiscal records must comply with the appropriate Office of Management and Budget (OMB) Circulars, which state the administrative requirements, cost principles and other standards for accountability.

2.23 Insurance. The Company will comply with the insurance requirements as provided in Attachment A, Insurance Requirements, attached hereto and incorporated herein.

2.24 Indemnity. (a) The Company will indemnify the Customer and their officers, employees, agents and volunteers for losses arising from any claim made by any person or entity, other than the Customer, alleging that (i) use of any Product resulted in bodily injury to the extent such claims arise out of manufacturing or material defects in Products and provided that the Product was used in accordance with Company-approved labeling, or (ii) any Product infringes the intellectual property of any other person or entity.

(b) If a credible claim is made or threatened, including without limitation the filing of a lawsuit against Customer, or Customer receives a demand or notice claiming actual or potential infringement or misappropriation of any intellectual property rights, Customer will use reasonable efforts to notify Company promptly of such lawsuit, claim or election. However, Customer's failure to provide or delay in providing such notice will relieve Company of its obligations only if and to the extent that such delay or failure materially prejudices Company's ability to defend such lawsuit or claim. Customer will give Company sole control of the defense (with counsel reasonably acceptable to Customer) and settlement of such claim; provided that Company may not settle the claim or suit absent the written consent of Customer unless such settlement (a) includes a release of all claims pending against Customer, (b) contains no admission of liability or wrongdoing by Customer, and (c) imposes no obligations upon Customer other than an obligation to stop using the Product that is the subject of the claim. In the event that Company fails to or elects not to defend Customer against any claim for which Customer is entitled to indemnity by Company, then Company shall reimburse Customer for all reasonable attorneys' fees and expenses within thirty (30) days from date of invoice or debit memo from Customer. After thirty (30) days, Customer will be entitled to deduct any unpaid invoice or debit memo amount from any amounts owed by Customer to Company.

(c) The Company will not be required to indemnify the Customer with respect to: any claim arising out of negligence or willful misconduct by the Customer; use of a Product by any person or entity other than in accordance with its labeling, misuse or alteration of any Product; or breach by the Customer of its obligations under this agreement to the extent that such breach is the proximate cause of the claim.

2.25 Direct Agreement. This agreement is unrelated to any agreement with any group purchasing organization of which the Customer is a member. The Company will not pay administrative fees to any group purchasing organization with respect to any Product purchased under this agreement.

2.26 Offer Expiration. Until fully executed, this agreement constitutes an offer that is valid until **June 5, 2022**. If the Customer does not sign it by that date, then the Company reserves the right to withdraw or modify this offer in its sole discretion. This agreement is not valid until all signatures required below have been made.

2.27 Warranty of Authority. The Customer represents and warrants to the Company that it is duly authorized to execute this agreement and that it has authority to legally bind the Customer to the terms of this agreement (including, without limitation, the agreement to arbitrate all disputes).

2.28 Signatures. This agreement and any amendment to this agreement will be executed by hand and signed copies may be delivered by mail or by electronic mail in Adobe Portable Format (.pdf) or similar format. Signatures provided and transmitted by a party using such means will be deemed original signatures. This agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same agreement.

ATTACHMENT A INSURANCE REQUIREMENTS

Without in anyway limiting the indemnification obligations in the agreement, Company agrees to secure and maintain insurance set forth in accordance with the requirements herein. Company shall secure and maintain throughout the contract term the following types of insurance with limits as shown:

- i. Commercial/General Liability Insurance – Company shall carry General Liability Insurance covering all operations performed by or on behalf of Company providing coverage for bodily injury and property damage with a limit of five million dollars (\$5,000,000), per occurrence and ten million dollars (\$10,000,000) aggregate. The policy coverage shall include:
 - a. Premises operations and mobile equipment.
 - b. Property damage
 - c. Personal and advertising injury.
 - d. Liability assumed under an insured contract
- ii. Product Liability Insurance – Company shall carry Product Liability insurance, including products/completed operations with limits of ten million dollars (\$10,000,000) each occurrence and in the aggregate.

Additional Insured – Commercial general liability policy shall include the County of San Bernardino and its officers, employees, agents and volunteers as additional insured with respect to liabilities arising out of the performance of services hereunder.

Waiver of Subrogation Rights – Where permitted by law and allowed by insurance, Commercial/General Liability coverage shall waive all rights of subrogation against Customer, its officers, employees, agents, volunteers, contractors and subcontractors, and such coverage shall not prohibit Company and Company's employees or agents from waiving the right of subrogation prior to a loss or claim.

Policies Primary and Non-Contributory – All policies required herein are to be primary and non-contributory with any insurance or self-insurance programs carried or administered by Customer for losses directly resulting from Customer negligence.

Proof of Coverage – Company shall furnish Certificates of Insurance to Arrowhead Regional Medical Center evidencing the insurance coverage upon written request.

Acceptability of Insurance Carrier – With the exception of product liability (which is insured via a captive insurance company), insurance shall be written by insurers authorized to do business in the State of California and with a minimum "Best" Insurance Guide rating of "A-".

Failure to Procure Coverage – In the event that any policy of insurance required under this contract does not comply with the requirements, is not procured, or is canceled and not replaced, Customer has the right but not the obligation or duty to cancel the contract or obtain insurance if it deems necessary and any premiums paid by Customer will be promptly reimbursed by Company or Customer payments to Company will be reduced to pay for Customer purchased insurance.

1. Products. This agreement includes only the Products from the Company as listed in Schedule A1.
2. Pricing. Subject to the terms and conditions of this agreement, the Company shall offer the Products at the pricing stated in Schedule A1.
3. Price Adjustments. The prices stated in Schedule A1 will be held firm for the term of this agreement.
4. Performance Requirements. Participants will only be entitled to the pricing under this agreement if, in a given Year, the Customer's Market Share for the Product Types listed in Schedule A1 meets or exceeds 85%. The Customer must complete Schedule A2: Purchase Analysis Information to indicate current purchase levels for all Participants and must provide Company with updates to the data in Schedule A2: Purchase Analysis for each given Year during each Performance Review.
5. Performance Review. The Company shall review the Customer's purchases each half Year or more frequently if indicated by changes in the Customer's purchases. If after such a review the Company determines that the Customer has not met or is not reasonably likely to meet the Performance Requirements or any other requirements for continued Pricing under this agreement, then the Company may, in addition to any other rights it has under this agreement and on giving 30 days' prior notice to the Customer, reduce any Discount or exclude any Product from this agreement.
6. Adding or Removing Products. The Company may at its discretion add or remove Products from this agreement.
7. Warranties. Any warranties provided by either the Company or any affiliate, as applicable, with respect to a given Product are as expressly provided in the labeling of that Product on purchase. THERE ARE NO WARRANTIES THAT EXTEND BEYOND THE FOREGOING DESCRIPTION INCLUDING, BUT NOT LIMITED TO, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
8. Definitions. For purposes of this agreement, the following terms have the following meanings:
 - "Market Share" for a given period means, the result, expressed as a percentage, of (1) the Net Contracted Purchases from Company, in dollars, of all products in the Product Types listed in Schedule A1 divided by (2) the sum of (A) the Net Contracted Purchases from Company, in dollars, of all products in the Product Types listed in Schedule A2 plus (B) the Net Purchases, in dollars, of all products in the Product Types listed in Schedule A2 sold by other suppliers.
 - "NCP" or "Net Contracted Purchases" means contracted purchases of Products by the Participants during a given period directly from the Company excluding all fees, shipping charges, taxes, and net of any returns.
 - "Net Purchases" or "NP" means purchases of all products in the Product Types listed in Schedule A1 by the Participants during a given period from other suppliers excluding all fees, shipping charges, taxes, distributor markups, and net of any returns.
 - "Product Type" means a grouping of products. The covered Product Types are listed in Schedule A1.
 - "Year" means each twelve-month period of this agreement, beginning on the Effective Date or anniversary thereof.
