THIS CONTRACT is entered into in the State of California by and between San Bernardino County, hereinafter called the County, and Life Generations Healthcare LLC referenced above, hereinafter called Contractor.

IT IS HEREBY AGREED AS FOLLOWS:

WITNESSETH:

IN THAT CERTAIN **Contract No. 23-1087** by and between San Bernardino County, a political subdivision of the State of California, and Contractor for Institution for Mental Disease services, which Contract first became effective September 26, 2023, the following changes are hereby made and agreed to, effective April 1, 2024:

- I. The original contractor, Generations Healthcare informed the County that its legal name is "Life Generations Healthcare LLC". Therefore, all rights, title and interests therein, are assigned to Life Generations Healthcare LLC and Life Generations Healthcare LLC accepts all of Generations Healthcare obligations, responsibilities and duties. All references to "Generations Healthcare" in the contract are replaced with "Life Generations Healthcare LLC".
