AMENDMENT TO ORDER FORM

This Amendment to Order Form (this "Amendment"), dated as of April 11, 2025 (the "Amendment Date"), modifies the Order Form executed by San Bernardino County California ("Customer") and Placer Labs, Inc. ("Placer") on or about February 6, 2024 (together with any other prior amendments thereto, the "Order Form"). Unless otherwise defined, capitalized terms herein have the same meaning as in the Order Form. Placer and Customer agree to amend the Order Form as follows:
