IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 5:

It is hereby agreed to amend Contract No. 21-629, effective upon execution as follows:

SECTION V. FISCAL PROVISIONS

Section V, is amended to read as follows:

- A. The maximum amount of reimbursement under this Contract shall not exceed \$3,165,998 which may consist of state and/or federal funds and shall be subject to availability of said funds to the County. The consideration to be paid to the Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

SECTION VII. TERM:

Section VII, is amended to read as follows:

This contract is effective as of August 24, 2021, and is extended from its original expiration date of August 23, 2025, to expire on August 23, 2026, but may be terminated earlier in accordance with provisions of Section IX of the Contract.

All other terms and conditions of Contract No. 21-629 remain in full force and effect.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
