### **BACKGROUND INFORMATION**

The County Administrative Office - Finance and Administration (Department) has increased staffing and is in need of converting existing conference room space into two cubicles to accommodate new staff. Currently, the Department is utilizing space in the County Counsel office area, however, County Counsel will need the space for its staff. The Department met with the Project and Facilities Management Department to discuss converting the Finance and Administration conference room into two cubicles and moving and or adding conferencing capabilities to the County Chief Financial Officer's office and other executive offices. In addition, the executive offices will undergo sound proofing to minimize noise levels from moving conferencing capabilities to executive offices.

Approval of Recommendations No. 1 and No. 2 will allow the Department to complete the projects necessary to expand office space to accommodate current staff levels and ensure conferencing capabilities.
