### ADDENDUM NO. 6

WHEREAS, County of San Bernardino on behalf of Arrowhead Regional Medical Center and Agiliti Imaging, Inc. entered into Service Agreement #Q141018 on March 10, 2020 with a term of May 1, 2020 through April 30, 2025 (“Agreement”); and

WHEREAS, the parties have since entered into five addendums modifying the terms of the Agreement, to, among other things, update the name of “County of San Bernardino” to “San Bernardino County”, modify the scope of work, revise the list of equipment to be serviced under the Agreement, and update the associated pricing for the services; and

WHEREAS, on April 1, 2024, Agiliti Imaging, Inc. (“Agiliti Imaging”) merged with Agiliti Health, Inc. (“Agiliti Health”) with Agiliti Health as the surviving company of the merger; and

WHEREAS, as a result of this merger, the parties desire to update the name of the contracting party in the Agreement; and

NOW THEREFORE, effective as of the date this Addendum is fully executed, the parties agree as follows:

1. All references in the Agreement to “Agiliti Imaging, Inc.” are revised to read as “Agiliti Health, Inc”.

2. All other terms and conditions of the Agreement, as previously amended, remain in full force and effect.
3. This Addendum may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Addendum. The parties shall be entitled to sign and transmit an electronic signature of this Addendum (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose names contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the party an original signed Addendum upon request.
