IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 2

It is hereby agreed to amend Contract No. 17-706, (SAP Contract No. 4400007133), effective August 23, 2021, as follows:

SECTION V. FISCAL PROVISIONS

Section V., Paragraph A. is amended to read as follows:

The maximum amount of payment under this Contract shall not exceed \$100,000, and shall be subject to availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

SECTION VIII. TERM

Section VIII is amended to read as follows:

This Contract is effective as of August 23, 2017 and is extended from its expiration date of August 22, 2021, to expire on August 22, 2022, but may be terminated earlier in accordance with provisions of Section IX of the Contract.

All other terms and conditions of Contract No. 17-706 remain in full force and effect.

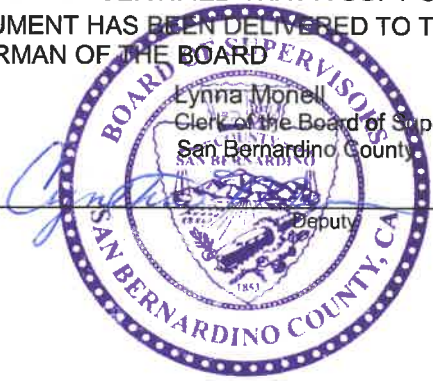
