Amendment No. 1 to
Memorandum of Understanding No. 20-1228
Between San Bernardino County Flood Control District and
San Bernardino County, through its Regional Park Department

San Bernardino County Flood Control District (DISTRICT) and San Bernardino County, through its Regional Park Department (PARKS), hereby seek to enter into this Amendment No. 1 to amend Memorandum of Understanding (MOU) No. 20-1228:

1. DELETE paragraph 4.4 and REPLACE with revised paragraph 4.4 that shall now read as follows:

Standard Contract Page 1 of 3

- 4.4. The Effective Date of this **MOU** shall be December 15, 2020. This **MOU** shall terminate on June 30, 2030, but may be extended by the **PARTIES** for one additional five year term by written amendment.
- 2. All other terms and conditions of MOU No. 20-1228 shall remain unchanged.
- 3. This Amendment No. 1 shall take effect on the date it is last signed by both parties.
- 4. This Amendment No. 1 may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment No. 1. The parties shall be entitled to sign and transmit and electronic signature of this Amendment No. 1 (whether by facsimile, PDF or other email transmission), which signatures shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment No. 1 upon request.
