### AMENDMENT NO. 2 TO AGREEMENT FOR NCTI AND ENRICHMENT SERVICES

#### IT IS HEREBY AGREED AS FOLLOWS:

The following is Amendment No. 2 to Contract No. 21-480 for NCTI and Enrichment Services.

**1. SECTION VIII. TERM is amended to read as follows:**

This Contract is effective as of July 1, 2021 and is extended from its original expiration date of June 30, 2024, to expire on June 30, 2026, but may be terminated earlier in accordance with provisions of Section IX of the Contract.

**2. SECTION X. GENERAL PROVISIONS, Section A is amended to read as follows:**




