RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY TO ESTABLISH NO STOPPING, STANDING, OR PARKING ZONE ON JAY BIRD LANE, MILL CREEK ROAD, AND TULIP LANE, BIG BEAR CITY AREA

On November 19, 2024, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Department of Public Works completed a traffic engineering investigation on Jaybird Lane (445750), Mill Creek Road (549300), and Tulip Lane (826400) in the Big Bear City area; and,

WHEREAS, the Board of Supervisors is authorized to establish parking restrictions on County roads; and,

WHEREAS, the Board of Supervisors desires to establish a parking restriction on Jaybird Lane, Mill Creek Road, and Tulip Lane in the Big Bear City area.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the welfare of the public utilizing Jay Bird Lane, Mill Creek Road, and Tulip Lane in the City of Big Bear Lake area, the Board of Supervisors, pursuant to a traffic engineering investigation, hereby finds and determines it necessary and hereby resolves to:

Establish a seasonal "No Stopping, Standing, or Parking Zone" from 7:00 a.m. to 5:00 p.m., November 1st to May 1st of each year, pursuant to County Code Sections 52.0118(a) and 53.0303:

- a. Along Jaybird Lane from Tulip Lane to Big Bear Lake city boundary in the Big Bear City area; and
- b. Along Mill Creek Road (from Tulip Lane northeast to Big Bear Lake city boundary in the Big Bear City; and
- c. Along Tulip Lane from Mill Creek Road to 220 feet north of Jaybird Lane in the Big Bear City area.
- 2. The County Road Commissioner is hereby directed to perform such acts as are necessary to establish the parking restrictions above and implement the terms of this resolution.
