RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BODY OF NAMED COUNTY SERVICE AREAS AND ZONES THEREOF, CONFIRMING REPORTS OF DELINQUENT WATER AND SEWER USER CHARGES AND PROVIDING FOR COLLECTION ON THE 2026-27 TAX ROLL

On Tuesday May 19, 2026, on motion of Supervisor _____, duly seconded by Supervisor _____ and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of the County of San Bernardino hereby finds and determines:

(a) That this Board is the governing body of the following County Services Areas and Zones:

(b) That the reports on water and sewer user charges, the payment of which is shown to be delinquent in said reports filed with the Clerk of the Board of Supervisors, are hereby confirmed for each property within said County Service Areas and Zones.

(c) That a public hearing on said reports was held on this date and that any protests or objections to the appropriateness of the charges or their collection on the tax roll were heard and considered.

SECTION 2. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of the named County Service Areas and Zones, therefore, hereby resolves and orders:

(a) That the charges set forth in said reports, as confirmed, shall be collected on the tax roll in the same manner and at the same time as general County ad valorem property taxes are collected for fiscal year 2026-27 in the above-named County Service Areas and Zones.

(b) That this resolution shall be effective May 19, 2026.

(c) That the Auditor-Controller/Treasurer/Tax Collector is directed to place the direct charge levies on the applicable tax roll in accordance with Government Code Section 25215.5 and in the same manner that the county collects and enforces property-related fees and charges for the property-related services that the county provides, including, but not limited

to, Article 4 (commencing with Section 5470) of Chapter 6 of Part 3 of Division 5 of the Health and Safety Code.
