

**RESOLUTION NO. 2020-09**

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO  
TO DECLARE ROAD RIGHT-OF-WAY ALONG MARYGOLD AVENUE IN THE BLOOMINGTON  
AREA**

On Tuesday, February 11, 2020, on motion of Supervisor Lovingood, duly seconded by Supervisor Gonzales and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the County owns property in the Bloomington area per Grant Deed recorded August 21, 2012 as Document Number 2018-0090099, 2018-0023465 and 2018-0024339 of Official Records of the County; and

WHEREAS, said County owned property (Assessor Parcel Numbers 0252-051-39, 0252-051-39, 0252-051-35) is located along the South side of Marygold Avenue approximately 1,000 feet westerly of its intersection at Locust Avenue; and

WHEREAS, on January 14, 2019 by staff action, the preliminary and Final Development Plans for the Bloomington Planned Development Project were approved subject to the conditions of approval; and

WHEREAS, as part of the Final Development Plans for the Bloomington Planned Development Project, the County, through the Land Use Services Department – Land Development section, has defined public road right-of-way needs along Marygold Avenue as it relates to the Bloomington Planned Development Project; and

WHEREAS, Marygold Avenue is currently designated as a Collector Street requiring 33.00 feet of road right-of-way (66 feet wide, 33-foot half-width); and

WHEREAS, the existing public road right-of-way along Marygold Avenue is not sufficient to meet the public's present and future needs as a Collector Street, and as a consequence it is now necessary for the County to declare, over that property owned by the County, thirty three feet (33.00') for public road right-of-way to meet the current Collector Street designation of 33-foot South half-width as shown on Parcel Map No. 20012.

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of the County of San Bernardino, State of California, that the Board finds and determines that all of the recitals contained hereinabove are true and correct, and, pursuant to Section 941 of the Streets and Highways Code of the State of California, it is now in the public interest to declare for public convenience public road right-of-way along Marygold Avenue over the following described portion of the County owned property:

BE IT FURTHER RESOLVED that the Clerk of this Board is hereby directed to cause a certified copy of this resolution, under the seal of this Board and delivered to the Department of Public Works, to be recorded in the official records of the County by said Department of Public Works.
