

**RESOLUTION NO. 2026- 11**

**RESOLUTION ESTABLISHING A RESTRICTED FUND BALANCE RESERVE  
FOR THE LUDLOW QUARRY MINING AND RECLAMATION PLAN**

On Tuesday, January 27, 2026, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS**, on January 12, 2016 (Item No. 30), the Board of Supervisors of the San Bernardino County (County) approved the acquisition of real property located in the Mojave Desert, adjacent to National Trails Highway, Assessor's Parcel Number (APN) 0552-141-17, consisting of an existing quarry of approximately 80 acres (the Ludlow Quarry), for a purchase price of \$40,000, plus escrow and title fees; and

**WHEREAS**, the Surface Mining and Reclamation Act of 1975 (SMARA), California Public Resources Code Section 2710 et seq., requires that the County provide financial assurance for the implementation of a mining and reclamation plan at the Ludlow Quarry site to ensure reclamation when borrow activities are completed; and

**WHEREAS**, a Mining and Reclamation Plan (Reclamation Plan) has been submitted to and approved by the Land Use Services Department-Planning Division and reviewed by the California Department of Conservation, Division of Mine Reclamation (State DMR) for the Ludlow Quarry; and

**WHEREAS**, the financial assurance for implementing the Reclamation Plan is \$384,263; and

**WHEREAS**, Sections 3802 and 3803 of the SMARA regulations (Title 14 of the California Code of Regulations) allow for government entity operators, such as the County, to use a budget set aside as a financial assurance mechanism subject to approval by the Land Use Services Department-Planning Division and review by the State DMR; and

**WHEREAS**, pursuant to County Policy No. 05-02, the Department of Public Works recommends reserving \$384,263 into a Restricted Fund Balance to act as the financial assurance for implementing the Reclamation Plan.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of San Bernardino County as follows:

- 1) The foregoing recitals are true and correct.
- 2) In accordance with Public Resources Code Section 2773.1, the Board authorizes and directs the establishment of a Restricted Fund Balance Reserve of \$384,263 in the Department of Public Works – Transportation 2025-26 Road Operations budget.
- 3) The Restricted Fund Balance Reserve shall remain in effect for the time period described in Public Resources Code section 2773.1(a)(2).
- 4) The Director of the Department of Public Works-Transportation is authorized and directed to take all necessary steps to implement the foregoing and submit the required financial assurance documents to the County's Land Use Services Department – Planning Division.
