THIS CONTRACT is entered into in the State of California by and between San Bernardino County, hereinafter called the County, and Rim Family Services referenced above, hereinafter called Contractor.

IT IS HEREBY AGREED AS FOLLOWS:

WITNESSETH:

IN THAT CERTAIN **Contract No. 21-436** by and between San Bernardino County, a political subdivision of the State of California, and Contractor for Environmental Prevention Strategies and Services, which Contract first became effective July 1, 2021, the following changes are hereby made and agreed to, effective May 24, 2022:

- I. ARTICLE IV Funding, paragraphs K and L are hereby amended to read as follows:
 - K. The contract amendment amount of \$559,033 shall increase the total contract amount from \$1,350,000 to \$1,909,033 for the contract term.
 - L. The Schedules A and B FY2021-22, 2022-23, 2023-24, and 2024-25 will be submitted to, and approved by, the Director or designee at a later date. All previously approved Budget Schedules remain in effect.

II. Addendum II Agreement for the Provision of Substance Use Disorder Services Environmental Prevention Strategies and Services, Section D. Program Requirements, paragraph 3. Program Objective is hereby amended to read as follows:

3. Program Objective

Contractor shall advocate, establish, and maintain evidence-based SUD prevention services and shall provide technical assistance to communities to achieve changes in conditions that reduce SUD problems among youth and young adults in San Bernardino County. The prevention services shall be provided in accordance with the County Strategic Prevention Framework and shall implement evidence-based prevention strategies in the regions. Contractor shall provide services as part of an integrated County effort, at community, regional, and county levels, to implement the Prevention Framework and support the SUD prevention priority areas described below and referred to as SUD Prevention Priority Areas.

- a. Alcohol Prevention
- b. Marijuana Prevention
- c. Methamphetamine Prevention
- d. Opioid Prevention

Contractor shall provide countywide technical assistance to the communities, cities, and stakeholders as approved by DBH.
