AMENDMENT NO. 6

It is hereby agreed to amend Contract No. 20-287, as follows:

SECTION V. FISCAL PROVISION

Amend Paragraph A to read as follows:

A. The maximum amount under this Contract shall not exceed \$6,000,000 and shall be subject to availability of funds to the County.
