**OVERVIEW**  
**REPORT ON LOCAL AREA TRANSPORTATION FACILITIES PLANS FINANCING FUNDS**  
**FISCAL YEAR 2023-24**

---

The County of San Bernardino has adopted transportation facilities plans for the financing of needed road improvements as growth continues in the County. The fees for each plan mitigate the impacts of development on certain roads. The fees for each plan were adopted based on this purpose and need to remain in effect. The fees are deposited into separate funds as required by the California Government Code.

Government Code section 66006(b) requires that the County make available to the public within one hundred eighty (180) days of the close of the fiscal year, certain information for each account or fund. More specifically, Government Code section 66006, subdivisions (b)(1) and (2) provide, in part, as follows:

"For each separate account or fund established pursuant to subdivision (a), the local agency shall, within 180 days after the last day of each fiscal year, make available to the public. . . a brief description of the type of fee in the account or fund. . . the amount of the fee. . . the beginning and ending balance of the account or fund. . . the amount of the fees collected and the interest earned. . . an identification of each public improvement on which fees were expended and the amount of the expenditures on each improvement, including the total percentage of the cost of the public improvement that was funded with fees. . . an identification of an approximate date by which the construction of the public improvement will commence if the local agency determines that sufficient funds have been collected to complete financing on an incomplete public improvement. . . a description of each interfund transfer or loan made from the account or fund. . . [and the] amount of refunds made pursuant to subdivision (e) of Section 66001 and any allocations pursuant to subdivision (f) of Section 66001. . . ."

In addition, Government Code section 66001(d)(1) requires the County to make certain findings for the fifth fiscal year following the first deposit into the account or fund and every five years thereafter.

This report and the supporting data described in the last paragraph of this overview have been prepared and furnished to comply with these Government Code requirements.

Revenues generated by the plans are not intended to fund fully the cost of the plans' transportation facilities projects. Fees levels have been developed to provide for only that portion of project costs attributable directly to new development. Additional state funds, Measure I, city/other agency contributions, and/or federal/grant funds are required for full funding of the projects listed in the plans.

Government Code section 66001, subdivisions (d)(2), (e) and (f) require that the agency, unless it demonstrates that the administrative costs of refunding would exceed the amount to be refunded, refund the unexpended or uncommitted portion of any fee collected (plus interest) if certain findings or actions are not made or taken. At this time, the plans are proceeding as contemplated, no refunds have been made and none are proposed pursuant to this section. There is still a need to construct the road improvements identified in the plans to mitigate the impacts of development.

Sufficient funds have not been collected by any of the plans to complete all of the improvements identified in the plans. It is not anticipated that refunds will occur in the near future. This information will be included in the annual report if refunds occur.

There also has not been any interfund transfer or loan from any of the plan funds. However, in some instances in order to construct a project and if funds collected are not sufficient, the County Department of Public Works Transportation Road Operations budget has advanced some funds from various sources such as Gas Tax or Discretionary General Funding. Those advancements are repaid to the Transportation Road Operations budget when fees get collected.

# FIVE-YEAR FINDINGS

In accordance with Government Code Section 66001, the County of San Bernardino makes the following findings with respect to those portions of the accounts or funds remaining unexpended, whether committed or uncommitted.

All unexpended funds held for five years or more are committed to projects that are a suitable purpose for the use of the developer fee.

## **A) Identify the purpose to which the fee is to be put**

The purpose of the fees collected on development is to fund the transportation facilities projects listed within the Board adopted Local Area Transportation Facilities Plan Reports (Local Plans) on file with the Clerk of the Board of Supervisors. In addition, the transportation facilities to be funded by these fees are summarized and shown in the Appendix section of this report. The project lists were developed as the minimal improvements deemed necessary to meet the basic transportation needs based upon projected development within the Plan boundaries. In preparing this report, the Department reexamined the local transportation facilities listed in each Local Plan Project List and found that there is still a need for the facilities due to the fact that projected growth from development will require improvements to the facilities to accommodate that development. All fees previously collected and those fees that will be collected for each Local Plan Area will be applied to the project costs for those Local Plan Area projects to mitigate the traffic impacts attributable to the new development.

## **B) Demonstrate a reasonable relationship between the fee and the purpose for which it is charged.**

Each Board adopted Local Plan contains a specific analysis on the relationship between the Local Plan's fee and development. In general, all Plans are based upon the cost of the improvements necessary to accommodate new growth divided by the number of trips estimated to be generated by the new development. This produces a fee per trip factor that is then multiplied by the number of new trips attributable to different types of development based upon trip factors as determined by the Institute of Transportation Engineers. Additional information specific to each Local Plan can be found in the adopted Local Plans on file with the Clerk of the Board of Supervisors. The County has reviewed each Local Plan project list cost estimate and growth projections and has determined that the Local Plan area fees reflect the actual costs of improvements attributable to the new development and determine that the relationship between the fees and the purpose for which the fees are charged is reasonable. Revenues generated by the Local Fee Plans are not intended to fund fully the cost of the Plan's transportation facilities projects. Fees levels have been developed to provide for only that portion of project costs attributable directly to new development.

## **C) Identify all sources and amounts of funding anticipated to complete financing.**

Sources and amounts of funding to complete financing for Plan projects can be found in the adopted Local Plans on file with the Clerk of the Board of Supervisors. The following table is a summary of the anticipated funding sources to complete all transportation facilities projects identified in the Local Plan project lists. However, project costs have increased since adoption of the Local Plans, and State funding has not been consistently available for a percentage of project costs. Additional funding sources and/or increases to the development fees will need to be identified to complete all the projects proposed in the Local Plans.
