

RESOLUTION NO. 2026-109

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BODY OF COUNTY SERVICE AREA 70, ZONE R-19 (COPPER MOUNTAIN), REPEALING PORTIONS OF RESOLUTION NO. 86-222 AND DECLARING RESULTS OF SPECIAL ELECTION FOR AN INCREASED PROPERTY RELATED SERVICE CHARGE FOR PROVIDING ROAD MAINTENANCE AND DIRT ROAD GRADING SERVICES

On Tuesday, June 23, 2026, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing body of County Service Area 70, Zone R-19 (Copper Mountain), hereby finds and determines:

- a) A mailed ballot election, pursuant to Proposition 218 and Cal. Const. art. XIII D, § 6(c), of property owners within County Service Area 70, Zone R-19 (Copper Mountain) (District) regarding the proposed increase to property related service charge from \$20 per parcel per year to \$75 per parcel per year (with an annual inflationary increase of up to 3%) for providing road maintenance and dirt road grading services, effective Fiscal Year 2026-27.
- b) The Board previously approved May 8, 2026, or any day thereafter, as the date for the mailed ballot election with the election conducted by an independent election service provider.
- c) Following the Board's approval of May 8, 2026, or any date thereafter, as the election date, the final election date was set for June 6, 2026. Ballots were mailed by the independent election service provider on May 11, 2026, and ballots postmarked by June 6, 2026, and received no later than June 12, 2026, were tabulated.
- d) The proposed increased property related service charge was approved by a majority vote of the property owners voting in the election (335 Approve, 310 Reject – 51.9%) of the properties subject to the service charge.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing body of County Service Area 70, therefore, hereby resolves and orders:

- a) The Board hereby adopts the certified election results for the proposed increased property related service charge, which was approved by a majority vote of the property owners of the property subject to the service charge.
- b) That pursuant to the property owner approval, there is hereby established an annual service charge of \$75 per parcel per year (with an annual inflationary increase of up to 3%), for road maintenance and dirt road grading services, effective Fiscal Year 2026-27.
- c) That those portions of Resolution No. 86-222 initially establishing an annual property related service charge of \$20 per parcel per year for road maintenance is hereby repealed.
- d) That the Auditor-Controller/Treasurer/Tax Collector is directed to place these charges on the applicable tax roll.

e) The Clerk of the Board is hereby directed to certify the passage of this resolution.
